Nearly 1 million Hoosier taxpayers qualify to file taxes for free through INfreefile, due to criteria such as having an Adjusted Gross Income of \$58,000 or less. INfreefile can connect your patrons to faster refunds, easy-to-use professional software and both federal and state tax filings. It's a one-stop shop for their individual income tax filing needs.
