Dear Friends:

Thank you for taking time to view the 2009 & 2010 biennial report of the Indiana Arts Commission. In the following pages we hope to share with you how the program and services of the Indiana Arts Commission impact the lives and economics of our great state.

The arts are more than something to do on a free evening or afternoon. Yes, the arts do improve our quality of life. We agree with President Abraham Lincoln's statement: "Show me a great civilization and I will show you a civilization with great art."

We at the Indiana Arts Commission share that belief, and are committed to share the arts as broadly as possible across our state because the arts should belong to everyone, everywhere. They should not be confined to large cities with major cultural venues, but also in small, rural community schools, libraries, and community centers.

We also know the arts mean real, full-time jobs for Hoosiers. According to a national economic survey by Americans for the Arts, there are more than 9,000 arts related businesses in Indiana. These include not-for-profit entities as well as private for-profit businesses. Nearly 50,000 Hoosiers are employed full-time by these arts-related businesses, and according to the 2000 U.S. Census, nearly 20,000 Hoosiers identify themselves as full-time artists deriving their primary source of income from their art. Every arts-related business and every one of their employees contributes to the local, state and national economy and tax base.

The Indiana Arts Commission also believes arts education is critical to developing creative problem solving skills, as well as instilling appreciation for the arts in future Hoosier artists and arts consumers. Two years ago, thanks to the loyal support of customers purchasing the Arts Trust special issue license plate, the Arts Commission began its Arts in Education program bringing grants to more than two dozen Indiana elementary and secondary schools to develop in-classroom arts programs.

Over the past 18 months, we have been successful in efforts to make the arts more accessible. We are proud of the fact that the Indiana Arts Commission was chosen as the 2009 recipient of the National Accessibility Leadership Award recognizing exceptional initiatives and programs to make the arts accessible and inclusive for older adults and individuals with disabilities.

We are pleased to share this report with you, and encourage you to join with us as we celebrate the arts and their impact on the lives of millions of Hoosiers.

About the Indiana Arts Commission's Grant Programs

Indiana has an impressive history of significant contributions to the arts. Home to artists such as T.C. Steele and Robert Indiana, designers Bill Blass and Michael Graves, entertainers Hoagy Carmichael and Crystal Gayle, Indiana has inspired and encouraged generations of Hoosiers.

For more than 40 years, the Indiana Arts Commission (IAC) has advocated for and extended grant support to Indiana artists and community-based cultural organizations. Strengthening the arts is critical to strengthening a dynamic and creative workforce throughout our state. Nearly 8,000 arts-related businesses call Indiana home and employ more than 48,000 Hoosiers.

The Commission first awarded 42 grants in 1969, and today, centrally and through its Regional Arts Partner system, annually awards grants to nearly 400 individual artists, arts organizations, and cultural program providers throughout the State of Indiana. Qualifying for an IAC grant has come to represent a "gold seal" standard of excellence. ***A breakdown of the grants in each county for FY2009 & FY2010 begins on page 23.***

American Masterpieces

Funded by the National Endowment for the Arts (NEA), the American Masterpieces program allowed states to award grants to organizations using the work of American Masters through touring, local presenting, and education programs. Projects were intended to showcase the best of American arts by utilizing significant American composers, choreographers, playwrights, photographers, visual artists, writers, and filmmakers. The program was initiated in 2006 and ended in FY2009.

American Recovery and Reinvestment Act (ARRA)

This federally funded program was administered through the National Endowment for the Arts (NEA) to preserve jobs at local arts organizations and cultural programming providers threatened by declining philanthropic support.

Arts in Education Grant (AIE)

In late 2008, the Indiana Arts Commission began accepting grant applications for a new Arts in Education Program funded in part by interest income from the Cultural Trust Fund (from purchases of the Arts Trust license plate) and increased funding from the National Endowment for the Arts (NEA). This program was developed to help support curriculum needs, impact individual student engagement and performance, and develop a long term commitment to arts in Indiana schools at the primary and secondary level. Initially, grant amounts ranged from \$5,000 to \$8,000 with applicants providing dollar for dollar matching funds, contributed funds, in-kind donations, or other services.

Capacity Building Program (CBP)

The Capacity Building Program actually began as the IAC's Technical Assistance Program. This grant allocation helped nonprofit arts and cultural organizations become more effective and efficient. Grants provide opportunities for technical assistance information focusing on nonprofit organizational assessment and improvement. The organizations' boards, staff and other key stakeholders, led by an independent consultant, examine their own agencies' capacity in areas of governance, management, and environmental challenges and opportunities. This program was suspended after 2009, as the IAC decided to offer Technical Assistance workshops.

Individual Artist Program (IAP)

The Individual Artist Program is designed to provide individual artists with grant assistance for specific projects that will further their career development. Grant funds may be used to meet the artists' needs in promotion, business development, and developing and reaching new markets for their work. The program encourages artists to develop projects that will have a positive impact on the communities where they live and work. IAP grant recipients often share their work with communities through performances, exhibitions, or by providing educational opportunities associated with the artists' projects.

Multi-regional Major Arts Institutions (Majors)

This grant program is for Indiana's major arts organizations, which serve nearly two million people annually. This includes more than a half-million school-aged children. To qualify for the Major Arts Organization status, an organization must have an

annual operating budget in excess of \$1 million, and provide arts and cultural services (with a focus on educational opportunities) on a statewide or multi-regional basis. These major organizations not only provide a significant economic impact in the communities where they are based, but also contribute to the economic and cultural tourism development of the entire state.

Presenter Touring Program (PTP)

Launched in 2008, this grant program was initiated to promote performances by Indiana performing artists and ensembles with Indiana-based cultural presenting organizations. Grants, funded from interest income from the Cultural Trust Fund (from purchases of the Arts Trust license plate), helped Indiana presenters in bringing Indiana artist ensembles to rural audiences. Applicants were required to provide a dollar for dollar match. Grants ranged from \$2,500 to \$7,500. This program was suspended in 2009 because of decreased State funding.

Regional Arts Partnership (RAP)

Regional Arts Partner organizations work with the IAC to provide four core services to community-based cultural organizations in specific geographical regions. These services include: cultural planning; grant-making; information and referral; and technical assistance. Regional Arts Partners receive an annual block grant allocation specifically formulated to meet the needs of organizations in individual regions. Block grant amounts vary by region. Regional Partners may also apply for specific technical assistance grants.

Regional Initiative Grant (RIG)

For most Regional Arts Partners, there are four categories of grants awarded to cultural programming providers as part of the Regional Initiative Grant program. Maximum grant request amounts are based on a variety of factors.

- **Arts Organization Support I (AOS I)**

This grant category is for arts organizations with annual cash income of \$250,000 or less. Organizations in this grant category may request a grant amount up to \$10,000 or 20% of previous year's operating income, whichever is less.

RIG (Continued)

- **Arts Organization Support II (AOS II)**

This grant category is for arts organizations with annual cash income of \$200,000 or more. Organizations in this grant category may request a grant amount of up to \$20,000 or 20% of previous year's operating income, whichever is less.

- **Arts Project Support (APS)**

Arts Project Support grants are designed for cultural program providers that do not have a primary arts-focused mission. Many libraries, universities, public schools and community centers could qualify in this grant category. Applicants may request up to \$5,000 or 50% of allowable project expenses, whichever is less. Average grant amounts are approximately \$1,800.

- **Mini-grants**

Some IAC Regions offer mini-grants for single project applications. As with Arts Project Support, the applicant need not have a primary arts-focused mission. Grants in this category generally range from \$500 to \$1,000 or 50% of allowable project expenses, whichever is less.

Statewide Arts Service Organizations (SWASO)

This grant program helps strengthen the capacity of arts organizations offering training and or technical assistance services on a statewide basis. Grants are limited to support for projects reflecting a distinct aspect of the organization's arts-related technical assistance activities. Such projects may include seminars, conferences, workshops and training sessions.

Other Indiana Arts Commission Statewide Efforts

In 2009 and 2010, the Indiana Arts Commission also had several other statewide initiatives, partnerships, and awards that benefitted the citizens of Indiana.

Accessibility Leadership Award

In 2009, the Indiana Arts Commission was awarded the Accessibility Leadership Award sponsored by the National Endowment for the Arts (NEA) and the National Assembly of State Arts Agencies (NASAA). The award recognizes exceptional initiatives or programs that make the arts accessible and inclusive for older adults and individuals with disabilities. The \$30,000 competitive grant allowed the IAC and ArtsWORK Indiana to expand support for artists with disabilities by offering Individual Artist Program (IAP) grants for projects that will impact the artist's career development. The IAC was also one of four states to receive a follow-up grant to form three ArtsWORK Indiana satellite groups in different areas of the state.

Arts Education Summit

In FY2009, the IAC partnered with Young Audiences Indiana to host an Arts Education Summit in conjunction with their Institute for Artful Teaching. The combined effort allowed Young Audiences to secure Ra Joy, Executive Director of the Illinois Art Alliance, to speak at the event about art advocacy. National and Statewide leaders focused on best practices in large and small group presentations as participants experienced how the arts are energizing education in schools & organizations throughout the country. The IAC and the Indiana Cultural Trust provided \$15,000 for this event.

Arts Midwest

Arts Midwest is one of six regional arts organizations in the U.S., serving audiences, arts organizations, and artists throughout the primary region of Illinois, Iowa, Michigan, Minnesota, North Dakota, Ohio, South Dakota, and Wisconsin.

Each year, the IAC provides a grant to Arts Midwest, which is then combined with other Arts Midwest support and regranting to presenters and performing artists from Indiana. This allows Indiana artists to tour throughout the Midwest, and Indiana presenters to showcase the best of Indiana and Midwest artists. In FY09 & FY10, Arts Midwest granted \$62,350 and \$58,604 respectively in our state which includes dues and additional funds by Arts Midwest. The grant amounts for the subgrantees from this program are included in the regional breakdowns beginning on page 10 of this document. Each organization is also listed by county beginning on page 23.

ArtsWORK Indiana

ArtsWORK Indiana is an informal, statewide group of people interested in improving arts-related professional opportunities and careers for people with disabilities. Participants include artists, as well as people involved in supporting opportunities for artists, such as rehabilitation professionals, college counselors, and arts administrators. Meetings are held on the third Thursday of the month in Indianapolis. Thanks to a special grant from the National Endowment for the Arts (NEA), additional satellite meetings have been set up in New Albany and Bloomington. ArtsWORK Indiana is a collaborative effort between VSA Indiana and the Indiana Institute on Disability and Community. For more information, please visit www.artsworkindiana.org.

Cultural District Program

In 2008, Rep. Eric Koch (R-Bedford) authored legislation to establish Indiana Statewide Cultural Districts. A cultural district is a well-recognized, labeled, mixed-use area of a community in which high concentrations of cultural assets serve as the anchor. Indiana Statewide Cultural Districts promote the exploration of and participation in the arts and humanities through cultural experiences that are unique to our communities. Indiana Statewide Cultural Districts support community life and economic vitality. Currently there is no funding associated with this program. In FY2010, the following communities were proclaimed Indiana Statewide Cultural Districts:

- Bloomington Entertainment and Arts District (BEAD)
- Carmel Arts & Design District
- Tippecanoe Arts and Cultural District

Cultural Trust Fund

The Cultural Trust Fund was created through legislative action in 1997, establishing a vehicle with which the IAC can enhance the funding, encouraging, promoting, and expanding of the arts in Indiana through financial resources outside the agency's biennial budget. For each \$40 Arts Trust license plate purchased, \$25 goes into the Cultural Trust Fund (the additional \$15 covers the BMV administrative fees). Interest from Cultural Trust Fund investments funded the Presenter Touring Program (in 2009) and the Arts in Education program (2009 - present).

Governor's Arts Awards (GAA)

Conceived in partnership between the IAC and the Office of the Governor, the GAA program recognizes and honors significant contributions to and profound positive impact on the arts in the state of Indiana. The awards are presented every two years and the event includes a dinner and ceremony. A local Indiana artist is also paid a stipend to create the award. In 2009 for the second time, the GAA ceremony was hosted by a community outside of Indianapolis and was held in Muncie. The IAC provided a grant of \$5,000 to the community of Muncie, which also raised over \$40,000 in sponsorships and in-kind donations to support the event.

Indiana Artisan

Indiana Artisan is a collaborative project that supports entrepreneurs who create high-quality art, crafts, and value-added foods in the Hoosier state. A venture of the Indiana Office of Tourism Development, the Indiana Office of Community and Rural Affairs, the Indiana Arts Commission, and the Indiana State Department of Agriculture, this comprehensive program was launched in 2008 to raise awareness about the availability of locally-crafted products and to encourage visitation to Indiana. In FY09, Indiana Artisan provided Business Development mini-grants to 22 artisans for activities intended to enhance business such as website design, printing and design services, and workshops. Indiana Artisan also provided Artisan Trail grants to 8 collaborative communities to promote Artisans through cultural tourism.

Poetry Out Loud

Each year, the IAC hosts the state Poetry Out Loud contest, a poetry recitation contest for high school students supported by the National Endowment for the Arts (NEA) and the Poetry Foundation. Students from Indiana first compete at the school level to determine the student who will represent their school at the state competition. The state champion then represents Indiana at the National Finals in Washington, D.C.

Traditional Arts Indiana (TAI)

Traditional Arts Indiana is a partnership of Indiana University's Folklore & Ethnomusicology Department and the IAC. Established in 1998 to document, promote and present Indiana's traditional arts and artists, TAI is housed in Bloomington, Indiana at the university. TAI views art as creativity found in everyday life - from how people cook, how they extract limestone from a hillside, how they dress, and how they decorate their homes and yards. The IAC contributed \$40,000 in FY 2009 and \$36,000 in FY 2010 to further the mission of TAI. More information on TAI can be found at www.traditionalartsindiana.org.

Regional Arts Partnership (RAP)

A cornerstone of the IAC's structure is a network of 12 regional partners to enhance the delivery of services and move decision-making about IAC funds closer to the people. Arts providers have better access to services and there is increased public awareness and advocacy for the arts at the community level. Each region receives administrative funds and funds for the Regional Initiative Grant (RIG) to distribute within the counties in their region.

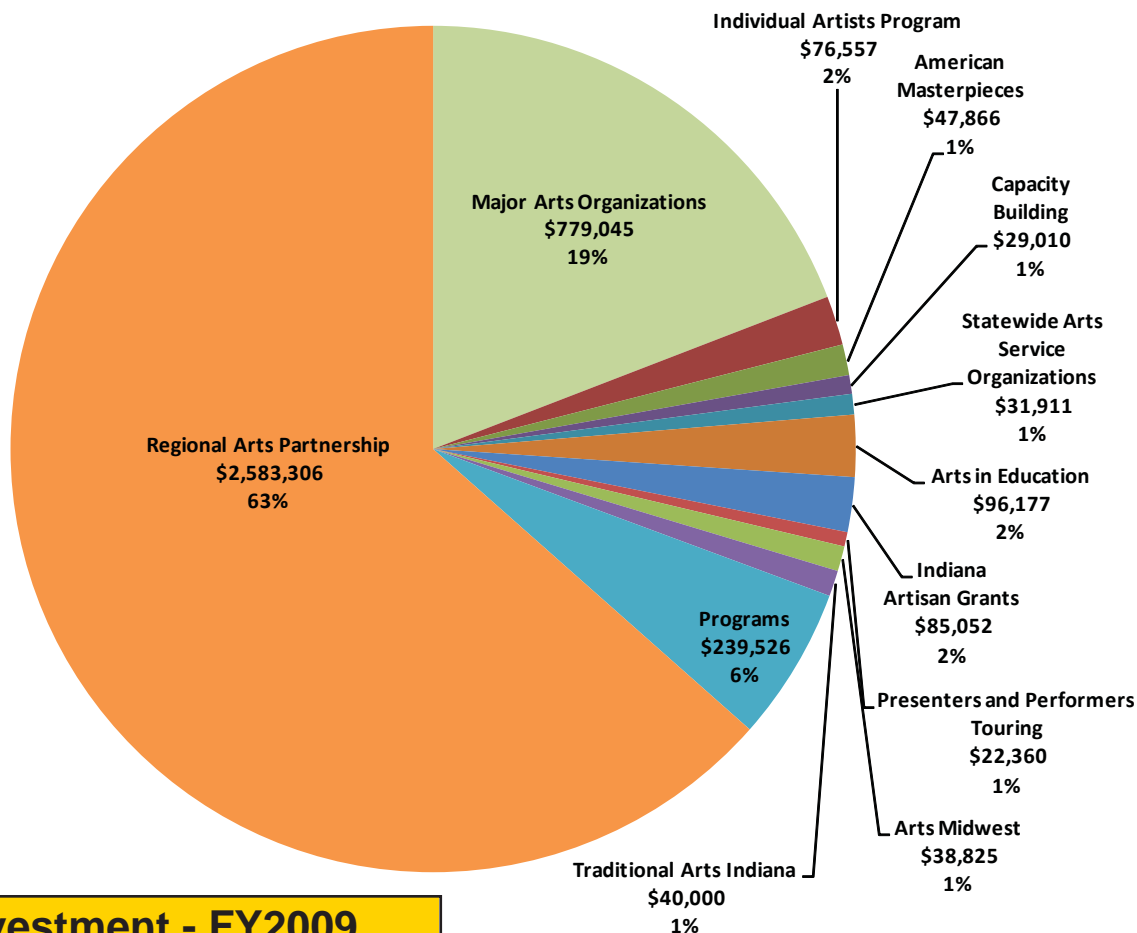

Technical Assistance

In 2010, the IAC suspended the Capacity Building grant program and decided to provide technical assistance workshops as a way to connect to constituents on an educational level. The first two seminars were held in June, 2010. The first, *Sharpening Arts Fund Raising and Constituent Building in our Current Economy*, took place in Lafayette and was presented by Dr. Tim Seiler of The Fundraising School, Center on Philanthropy at Indiana University. The Tippecanoe Arts Federation hosted the event. The second, *Leading at the Speed of Change*, took place in Bloomington and was presented by ArtsLab, a Minneapolis-based collaborative initiative. The City of Bloomington hosted the event with the support of Arts Midwest. The IAC also joined forces with the Indiana Coalition for the Arts (INCA) and offered free attendance to organizations and individuals that joined or were already members of INCA.

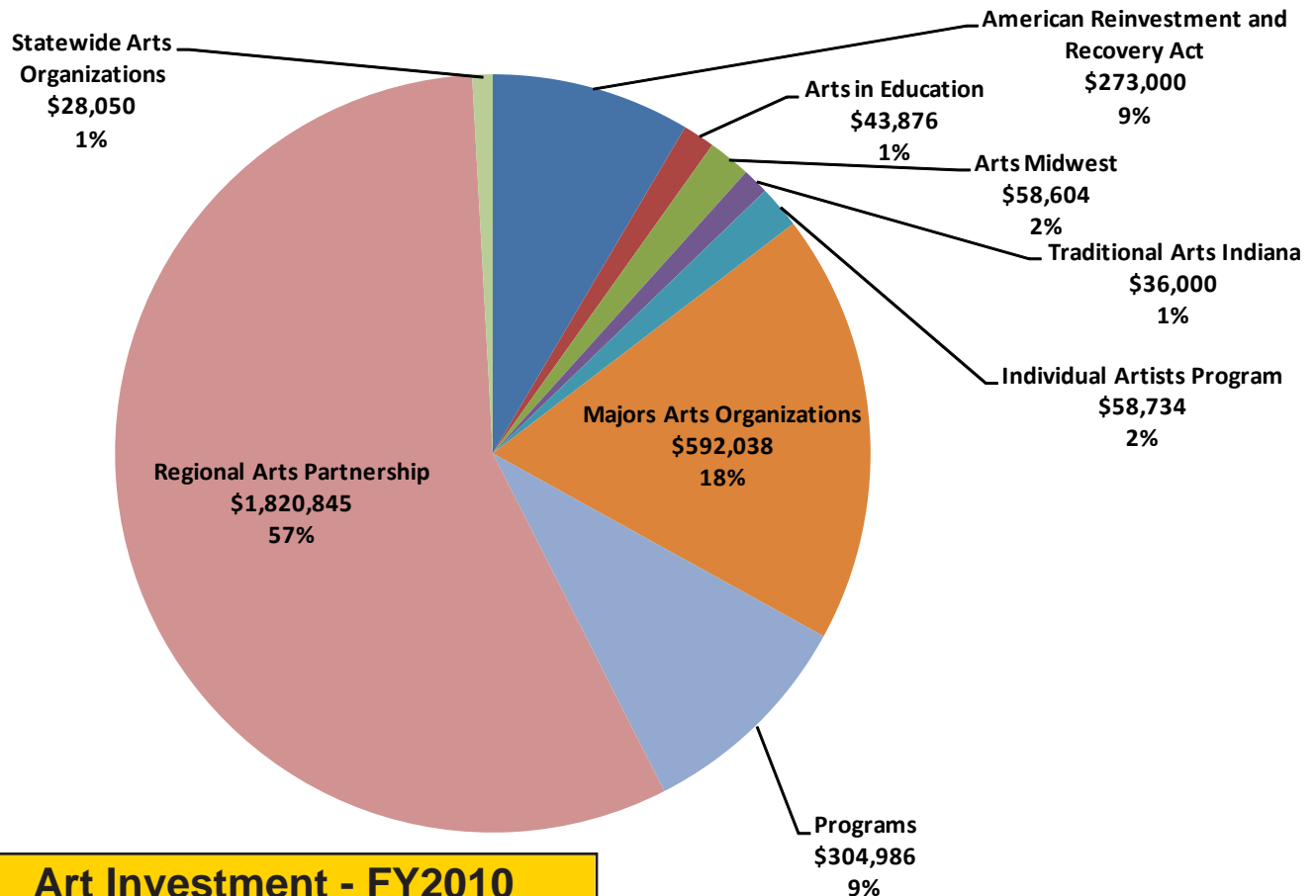

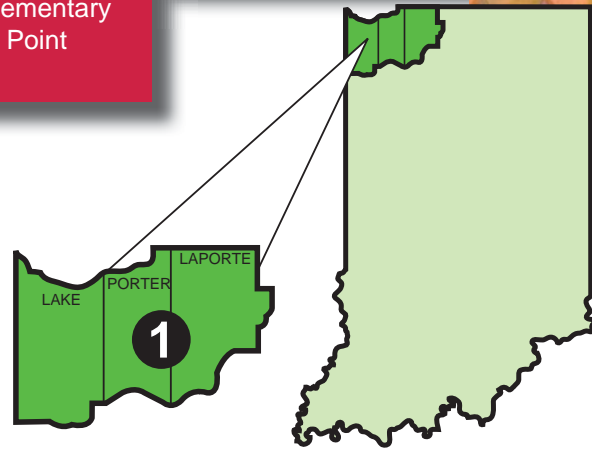

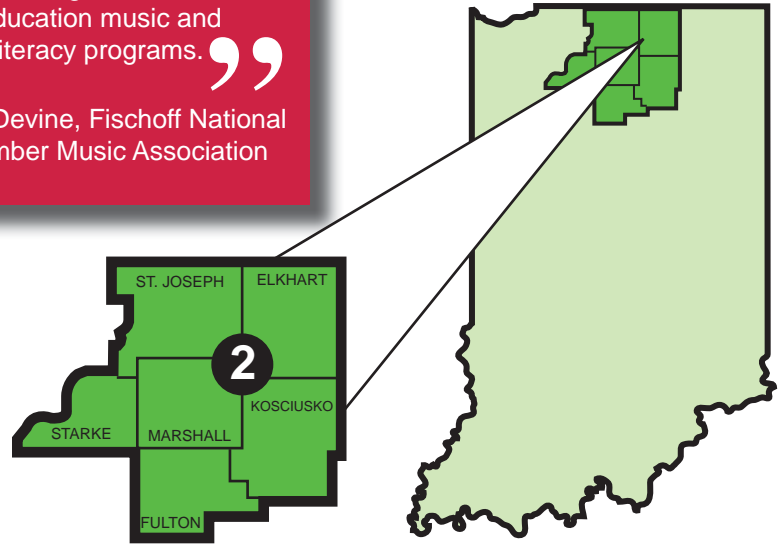
