**CALL TO ORDER/NOTING OF QUORUM**

### **ANNOUNCEMENTS**

INDIANA STATE EXCISE POLICE OFFICER FORMATO MERITORIOUS SERVICE AWARD – Chair Allen stated due to Officer Joe Formato’s immediate actions in response to his felonious attack on September 29, 2022, which presented outstanding reaction to the incident. In addition to the immediate life-preserving actions he took during this incident, he displayed extreme professionalism in the days, weeks and months that followed. His courageous actions and professionalisms displayed were admirable, commendable, and therefore he was presented with the award for Meritorious Service.

INDIANA STATE EXCISE POLICE MASTER OFFICER FENSTERMAKER LIFESAVING AWARD – Chair Allen stated on Wednesday, November 25, 2023 at approximately 10 am, Master Officer Ben Fenstermaker responded to a 911 call that reported an unconscious male subject. Additional information was difficult to obtain due to a language barrier, however, it was believed a child was not breathing. Master Officer Fenstermaker was first on scene and located a 19-year-old male, unresponsive and laying in bed. Maser Officer Fenstemaker quickly assessed the young male subject for a pulse and did not detect one. By this time, Officer Brian McClish, with the Ossian Police Department, arrived to assist. Officers then moved the young male to the ground to allow more room to render aid. Due to the young man not having a pulse, Master Officer Fenstermaker used his department issued AED. After placing the AED pads on the subject and a taking a quick assessment, the AED delivered one shock to

the young, male subject. Once the shock was delivered, the first responders from numerous agencies continued to perform patient care. It was noted that the young male's pulse was restored, and Wells County EMS transported the young male subject to the hospital. Master Officer Fenstermaker's quick response and actions quickly resulted in saving the life of the young male subject. For the above-stated reasons, Master Officer Fenstermaker is presented the Life Saving Award.

Chair Allen noted we have a lot of excellent officers but wanted to recognize these two for their service.

Commissioner Maginn and Commissioner Jones also commented on the outstanding service these officers provide.
