#### ALCOHOL AND TOBACCO COMMISSION

## **OCTOBER 1, 2024**

# CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

#### **DISPOSITION OF MINUTES**

Vice Chairman Payne moved to approve the minutes from the September 17, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

#### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Sixty-four dispositions were submitted with fines totaling \$48,050.00. Commissioner Jones seconded. The motion was unanimously approved.

#### HEARING JUDGE'S RECOMMENDATIONS

<u>RR33-39970 EL CAJON DE ARAUCA AGRITAINMENT RANCH LLC</u> – Vice Chairman Payne, who sat as hearing judge in this matter, stated this application was denied and appealed by the applicant. The location has issues with sewer and septic. The applicant was given time to try and resolve these issues, but was unsuccessful. The Hearing Judge now submits Proposed Findings of Fact and Conclusions of Law for recommendation to the Commission.

Vice Chairman Payne moved to uphold the local board's denial of this new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL44-33357 DOLGENCORP LLC</u> – Vice Chairman Payne, who sat as hearing judge in this matter, stated this application for a new permit was approved by the local board, but denied by the Commission. A timely appeal was filed by the applicant. The location of this business is in Shipshewana, Indiana, which has been diligently remonstrating against alcohol permits in this city for many years. There is one permit operating there only for events with no carry-out and a two-drink limit during the event. This application is a grocery permit where alcohol is carried out. The Hearing Judge now submits Proposed Findings of Fact and Conclusions of Law for recommendation to the Commission.

Vice Chairman Payne moved to uphold the denial of the new permit. Commissioner Maginn seconded. Commissioner Jones stated the applicant's objections to the proposed findings are compelling, however, he will vote to uphold the motion. Chair Allen voted to approve the motion. The motion passed 4-0.

#### CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine shipper applications. Commissioner Maginn seconded. The motion was unanimously approved.

#### WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

## **ITEMS FOR DISCUSSION**

<u>RR72-41490 5-7-10 LLC</u> – Chair Allen noted this is a new application with the local board voting 4-0 to approve. This was continued from the September 17<sup>th</sup> meeting.

Commissioner Maginn stated this is a bowling alley business. The remonstrator present at the hearing is a pizza place in the same building, but with a separate address. There is a contract between the businesses that makes the pizza restaurant the sole provider of food and alcohol to the bowling alley.

Commissioner Maginn moved to continue this to the October 16<sup>th</sup> meeting to allow time for research to be completed regarding the legality of the contract. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR40-37915 SUPERMERCADO LA MEJOR LLC</u> – Chair Allen noted this is a request for a catering hall designation.

Commissioner Maginn stated this is currently a restaurant. A new building is being built next to the current building, which will serve as the catering hall. This designation will only allow the business to be a catering hall and no longer a restaurant.

Commissioner Maginn moved to approve the request for a catering hall designation. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-06959 H.A.T. ENTERPRISES, INC.</u> – Chair Allen noted this is on for an extension request continued from the August 20, 2024 meeting.

Commissioner Maginn stated this establishment has had many problems over the years. There are unsettled violations, and the business is not ready to open.

Commissioner Maginn moved to continue this to the October 16<sup>th</sup> meeting. Vice Chairman Payne seconded. Chair Allen voted to approve the motion. Commissioner Jones abstained. The motion passed 3-0 with one abstention.

<u>RR22-39401 WILD EGGS OPERATIONS LLC</u> – Chair Allen asked that the Commission remove this from the agenda by consent because it is no longer needed. Consent was given.

RR84-40209 NEW GOSHEN PUB, INC. - Chair Allen noted this is on for a second extension request.

Commissioner Maginn stated one of the owners passed away and there are ownership changes that are being addressed and there is no certificate of insurance on file.

Commissioner Maginn moved to approve a 30-day extension to allow time for the certificate of insurance to be submitted. Vice Chairman Payne seconded.

Commissioner Jones asked if ownership information is also needed. Commissioner Maginn thought it might be. General Counsel Merritt stated that she has ownership information.

Vice Chairman Payne asked if this would need an additional hearing and Commissioner Maginn stated it would be set out for 30 days.

The motion was unanimously approved.

RR22-00892 MYBAR GUYS LLC - Chair Allen noted this is on for an extension request.

Commissioner Maginn stated there is a Form 1 issue and also an issue with the Secretary of State because their Certificate of Existence expired two years ago, so it needs to be updated.

Commissioner Maginn moved to grant a 30-day extension to allow time for filing the Form 1 and to submit a new Certificate of Existence. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR29-36708 K & L RESTAURANT LLC</u> – Chair Allen noted this is on for a second extension request. Chair Allen asked the commissioners to add this to the agenda by consent. Consent was given.

Commissioner Maginn stated the permit expired in June. They were cited for operating without a permit, no employee permits and no record of employee permits. A Settlement Offer has been sent regarding the violations. Renewals have been filed and a first extension was granted. The Commissioner also mentioned the permit processor has requested a corrective action plan and certificate of insurance be submitted.

Commissioner Maginn moved to approve a 30-day extension to allow time for the submission of the corrective action plan and certificate of insurance. Vice Chairman Payne seconded.

Chair Allen stated the corrective action plan should include employees will be licensed and trained.

Commissioner Jones clarified the meeting date for all of the above-referenced continuances is November 6<sup>th</sup>.

The motion was unanimously approved.

## **INACTIVE FILES**

Vice Chairman Payne moved to make 12 permits dead that were posted on the September 17, 2024 meeting agenda. Commissioner Maginn seconded. The motion was unanimously approved.

Chair Allen stated there are 10 permits announced today, to be made dead at the October 16, 2024 meeting. The Commission has worked extremely diligently to make sure permittees are notified of this date.

# Noteworthy Violations for 10/1/24 Commission Meeting

RR4928549: Waterville Associates LLC (DBA: Casba) in Indianapolis, Marion County. On May 31, 2024, Excise officers conducted an undercover investigation inside the business in response to various complaints from IMPD. The business had also been the subject of numerous police runs during the beginning of 2024. During the investigation, officers came into contact with the owner, who was belligerent, aggressive and believed to be intoxicated. Numerous violations were written, to include: public nuisance, lack of employee permits, minimum food requirements, hindering, lack of manager's questionnaire, falsification of records and various signage issues. This was the third violation at the business in the past year. The parties have agreed to a \$1,500 civil penalty and a 3-day suspension of the alcohol permit.

RR4928549: Suite 38 Inc. (DBA: Limelight Night Club) in Indianapolis, Marion County. In January 2024, the Marion County Task Force was notified that a 17-year-old girl was assaulted inside the business. After investigation, a violation was written for allowing a minor inside the club. This was the last in a long line of issues involving juveniles being allowed entry and/or being served at the business. The parties have agreed to a \$1,000 civil penalty and in lieu of further suspension or revocation of the permit, the business will remain closed and agreed to seek transfer of the permit to an unrelated party at a new location.

TC16409001: Galaxy Smoke Shop Inc. (DBA: Galaxy Smoke Shop) in Plymouth, Marshall County. In early 2024, District 1 Officers received a complaint that the business was located too close to a school. Officer Javier Arroyo was assigned to investigate and determined the business was located less than the 1000 feet required by law. He also located the tobacco certificate application and found that the business did not disclose this information to the Commission. The parties have agreed to revocation of the tobacco certificate.
