ALCOHOL AND TOBACCO COMMISSION

NOVEMBER 6, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the October 16, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Eighty-one dispositions were submitted with fines totaling \$46,650.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine shipper applications. Vice Chairman Payne seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

RR42-34083 THE ALAMO STEAKHOUSE LLC – Chair Allen noted this is a renewal application with the local board voting 3-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

RR16-41883 LITTLE BUG LLC– Chair Allen noted this is a request for a catering hall designation.

Commissioner Maginn moved to conditionally approve the request until the base permit is issued. Commissioner Jones seconded. The motion was unanimously approved.

RR46-41539 LICKITY SPLITZ INC – Chair Allen noted this is a new application with the local board voting 4-0 to approve.

Commissioner Maginn stated there was a remonstrator at the local board hearing.

Commissioner Maginn moved to uphold the local board's recommendation to approve the new permit. Vice Chairman Payne seconded. The motion was unanimously approved.

RR46-36227 EL MACHETE INC – Chair Allen noted this is a renewal with the local board voting 2-2.

Commissioner Maginn stated the business has a restaurant permit inside a grocery store, which is not allowed sell carry-out. There seems to be confusion with the owner and what is allowed at the business.

Commissioner Maginn moved to approve the renewal, and to require strict compliance of the law. She also asked legal to send a letter instructing the owner on what is allowed and for Excise to visit and explain what is lawful at the business. Vice Chairman Payne seconded. Chair Allen voted to approve the motion. Commissioner Jones voted no. The motion passed 3-1.

RR49-36555 MIMI'S EVENT LOUNGE LLC – Chair Allen noted the next item comes on as a request from Prosecutor Wignall for reconsideration of their extension letter. Also, the permittee requested to be placed in escrow.

Chair Allen moved to revoke the extension. Commissioner Jones seconded. The motion was unanimously approved.

RR84-40209 NEW GOSHEN PUB INC – Chair Allen noted this is on for an extension request continued from October 1, 2024.

Commissioner Maginn stated this was continued due to missing items. The Commission has received all items except for probate assignment.

Commissioner Maginn moved to approve the extension for two weeks and reset the matter for November 19th for an update. Vice Chairman Payne seconded.

Commissioner Jones asked how a non-existing entity can be insured and provide a Certificate of Insurance.

Commissioner Maginn stated that may have to be corrected after the determination of who is awarded the permit, and we would need proof of insurance in that name.

Chair Allen suggested in the next two weeks, the legal staff should reach out and find what a carrier would do if the entity doesn't actually exist to determine if that would be a valid policy. The Chair also suggested looking into our statutes regarding probate to see if this situation is covered if the permittee legally does not exist.

Attorney Jeff McKean stated the entity does exist, but one shareholder has died. The corporation is valid with Secretary of State.

The motion to approve a two-week extension and to request a probate update was unanimously approved.

RR29-36708 K & L RESTAURANT LLC – Chair Allen noted this comes on for an extension request. The Commission received a corrective action plan this morning and has not had time to review.

Commissioner Maginn stated it appears there are still items missing that should have been submitted, but she did not have time to review the submission from this morning.

Commissioner Maginn moved to approve another two-week extension. Vice Chairman Payne seconded, but stated he continues to not understand why permittees do not follow the law and submit a completed application at the beginning.

Commissioner Jones noted the certificate of liability insurance was submitted this morning, but it is unclear whether both parties are covered. The permit is being transferred.

The motion was unanimously approved.

RR49-35771 EL FANDANGOS INC – Chair Allen noted this comes on for an extension request. The Commission timely received a corrective action plan and updated documents.

Commissioner Maginn stated paperwork was filed with the Secretary of State, however, the issue is still pending.

Commissioner Maginn moved to approve a two-week extension. Vice Chairman Payne seconded, but stated the corrective action plan needs to be more detailed as to how the problems are going to be solved, not just that they are solved.

Chair Allen stated there was an amended corrective action plan submitted that provides more details as to what is being done to correct the problems.

Commissioner Jones noted the business has been dissolved twice so there is a question as to who is covered on the certificate of insurance.

The motion was unanimously approved.

RR45-01021 MENCHACA LTD – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated the corporation has been dissolved for five years, so work needs to be done with the Secretary of State and also the certificate of insurance.

Commissioner Maginn moved to approve a 90-day extension, beginning today. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen stressed the importance of these corporations keeping current with the Secretary of State because it provides liability protection for them personally that may not be available otherwise.

RR49-37266 CARNICERIA Y TIENDA MI MEXICO 1 LLC – Chair Allen noted this is on for a second extension request.

Commissioner Maginn stated this business has a tax protest and has been cited for falsification of records. The Commissioner requested legal check into the background of the owners.

Commissioner Maginn moved to deny the extension request. Commissioner Jones seconded. The motion was unanimously approved.

RR49-41008 CROSS ULTRA LOUNGE LLP – Chair Allen noted this is on for an extension request. She also noted the renewal was approved at local board on November 4, 2024.

Commissioner Maginn moved to approve the extension. Vice Chairman Payne seconded. The motion was unanimously approved.

DL06-32580 7M'S GROCERY INC – Chair Allen noted this is on for an extension request.

Commissioner Maginn moved to approve a fee-waived extension due to a processing error. Commissioner Jones seconded. The motion was unanimously approved.

RR71-35820 TAVERN ASSOCIATES II LLC – Chair Allen noted this is on for an extension request.

Commissioner Maginn moved to approve the extension request conditional on removal of the tax protest. Commissioner Jones seconded. The motion was unanimously approved.

DL20-11316 STERLING AVENUE LIQUOR STORE INC – Chair Allen noted this matter is on for a request to reactivate/transfer the permit.

Commissioner Maginn stated the business was administratively dissolved five years ago. The Commission requested documents for renewal, escrow, transfer and payment of a fine. The documents were received except for portions of the transfer.

Commissioner Maginn moved to approve the reactivation of the permit and to allow 30 days for the missing transfer documents to be filed so it can be set for local board. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-41100 HERLO LLC – By consent, this matter was added to the agenda.

Chair Allen stated this is on for an extension request that was continued from October 22nd. She also stated the renewal was approved at the November 4, 2024 local board hearing.

Chair Allen moved to approve the extension request.

Commissioner Jones asked if the Form 1 Property Tax form was still missing.

Commissioner Maginn suggested amending the motion to be conditional upon receipt of the Form 1 and the certificate of insurance.

Chair Allen amended her motion to conditionally approve extension upon receipt of the Form 1 and certificate of insurance. Vice Chairman Payne seconded. The motion was unanimously approved.

PRIOR CONDITIONAL APPROVALS FOR RECONSIDERATION – Chair Allen stated that on September 17, 2024, the Commission adopted Non-Rule Police #32 regarding conditional approvals with holds, giving permittees 30 days to contact us or provide the missing information. The Chair sent notices for the list of permits from that meeting notifying the permittees of the new policy. This is the first meeting to consider the permits from September 17th.

Chair Allen stated that in preparing for this she noted there were 66 permits on the September 17th list showing 159 touches of the files by the processors. If each of the touches takes 5 minutes, that adds up to 13.52 hours, or 2 days of time in just trying to get these 66 permittees to clear up the missing items so the permits can be issued. The Chair commented on the stress to the processors and the inefficiencies this creates in the workflow. She also recommended requiring the certificate of insurance being submitted up front because 20 of the 66 holds were for that document.

Vice Chairman Payne stated he is so impressed with Chair Allen for all of the time, work and detail she put in regarding this process. He also noted how astounded he is that businesses run with so little compliance of laws and regulations because having these permits is a privilege not a right. The Vice Chairman mentioned getting stricter by not granting extensions and approving permits without compliance, so permittees get the message.
