ALCOHOL AND TOBACCO COMMISSION

FEBRUARY 20, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, General Counsel Merritt, Deputy Director Serak, and Prosecutor Wignall were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the February 6, 2024 meeting. Commissioner Maginn seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Forty-five dispositions were submitted with fines totaling \$24,050.00. Commissioner Maginn seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

RR6039184 TOREMAC LLC - Vice Chairman Payne stated this permittee was denied renewal. There were issues regarding convictions of the owner not being disclosed on the application. The permittee filed a timely notice of appeal, and the matter was set for hearing.

During the hearing it was noted that the permittee owns other establishments in other counties and the permits for those were renewed, with the same non-disclosure of convictions. There were community members present at the appeal hearing that stated the owner is a good businessman and is very generous in the community. While there is a language barrier and the owner used a preparer to file the paperwork, it is still the owner's responsibility to provide correct information to the Commission. Also, the convictions would not, on their own, disqualify the permittee from holding this permit.

Vice Chairman Payne moved to overturn the denial and approve the renewal. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen noted that conviction information is available to the public. There is no excuse for permittees not disclosing the information requested on the application.

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of

these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

RR7140835 EAST BANK EATS, LLC – Chair Allen noted this is a new application with the local board voting 4-0 to approve.

Commissioner Maginn stated there was a remonstrator present at the hearing who lives very near the location of this permit. The remonstrator questioned the character of the applicant due to delinquent taxes and issues with this economic development project.

Commissioner Maginn moved to uphold the local board's recommendation to approve the new permit. Commissioner Jones seconded. The motion was unanimously approved.

RR4940479 HALAL MARKET & HABESHA RESTAURANT LLC – Chair Allen noted this is a new application with the local board voting 3-1 to approve.

Commissioner Maginn stated the owner seemed to have trouble grasping laws and regulations for holding an alcohol permit, but he has a cousin who was present at the local board hearing who seemed to understand and was going to be helping with the business.

Commissioner Maginn moved to uphold the local board's recommendation to approve the new permit for 1 year. Commissioner Jones seconded. The motion was unanimously approved.

RR4940522 BLUE TURTLE APP CO LLC – Chair Allen noted this is a transfer with the local board voting 4-0 to deny for failure to appear at the local board hearing.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

RR4937477 SILVER BULLET BEECH GROVE LLC – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated there have been numerous police runs to the business, two incidents were shootings. The owners have lately been talking to the police to help, but there are questions as to why it took so long before the owner decided to try and correct the problems. A corrective action plan was submitted.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones stated he was somewhat concerned about possible inaccurate testimony at the local board hearing, but because of the seriousness of the problems, he supported the denial of the renewal.

RR4932155 TORTAS EL GUERO 2 INC. – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated there was a minor serving alcohol. The owner said he was unaware of any issues.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

RR4932573 SREE PROPERTIES LLC – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated there was a remonstrator present. During the week, the business operates as a restaurant, but on the weekend it becomes more of a nightclub. There have been several violations, including serving alcohol to minors as young as 16 and 17.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

RR1440448 LA KATRINA LLC – Chair Allen noted this is a new application with the local board voting 4-0 to deny for failure to appear at the local board hearing.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

RR2940704 SMOKY ROW PIZZA CO LLC – Chair Allen noted this is a new application with the local board voting 3-0 to deny.

Commissioner Maginn stated the location is in a fairly residential area. There were several remonstrators present at the local board hearing. The owner's reputation came into question. The community stated they did not desire this business.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

DL4516057 L & RS INC. – Chair Allen noted this is a request for extension. There are issues with this permit regarding ownership that are complicated. The Chair recommended approving a 90-day extension and during that 90-day period, hold an investigative hearing regarding the ownership to work out the details and possibly prevent a back and forth of paperwork filings.

Commissioner Maginn stated she would like to at least have an affidavit filed clarifying what happened and why information was not corrected over the last few years.

Commissioner Jones moved to approve the 90-day extension and to hold an investigatory hearing during that time to discuss and correct the ownership of this permit. Commissioner Maginn seconded. The motion was unanimously approved.

RR4937477 SILVER BULLET BEECH GROVE LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn stated Commission denied the renewal today and moved to grant the extension if an appeal is filed.

Chair Allen asked if the Commissioner would accept an amendment to grant the extension until the deadline to appeal occurs and if an appeal is filed, extend the length of the extension.

Commissioner Jones asked that the permittee begin operating under the corrective action plan that was just submitted.

Commissioner Maginn moved to amend the original motion to include approving the extension until deadline to appeal occurs and if denial is appealed, extend the extension, and the permittee is to begin operating the business as stated in the corrective action plan that was just submitted. Commissioner Jones seconded. The motion was unanimously approved.

RR2937928 CROWN NAILS SALON LLC - Chair Allen noted a request for extension was submitted however, the renewal of this permit was denied, and an appeal was filed, but filed late, so there is no permit to extend.

Commissioner Maginn moved to deny the extension request. Commissioner Jones seconded. The motion was unanimously approved.

DL4504813 ECONOMY PACKAGE LIQUOR 3 - Chair Allen noted this is a request for extension.

Commissioner Maginn moved to approve the request for extension. Commissioner Jones seconded. The motion was unanimously approved.

RR4933683 MPAG LLC – Chair Allen noted this is a request for extension. The permittee just resolved violations with the prosecutor. The Chair would like to make sure the business has corrected the issues that led to the violations being filed, so she recommended a 2-week extension until the next meeting to make sure the issues have been corrected.

Commissioner Maginn moved to approve an extension for 2 weeks and if issues corrected, grant the additional extension period at that time. Vice Chairman Payne seconded. The motion was unanimously approved.



Noteworthy Violation for 2/20/24 Commission Meeting

RR4937477: Silver Bullet Beech Grove LLC (DBA: Silver Bullet Pub) in Beech Grove, Marion County. On August 10, 2023, the Marion County Task Force received notice of a shooting at the business from the Beech Grove Police Department. Further investigation led to reports of numerous, prior police runs to the location. Based on the number and nature of these reports, a Public Nuisance violation, along with other violations for falsification of records and unlawful time of alcohol sales, was served by the Task Force. **The parties have agreed to a \$1,500 civil penalty, a Corrective Action Plan, and the business is being placed in the PACE program.**
