MINUTES

ALCOHOL AND TOBACCO COMMISSION

MARCH 19, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, General Counsel Merritt, and Deputy Director Serak were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the March 5, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Sixty-five dispositions were submitted with fines totaling \$40,800.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

By consent, the Commission added MM49-30817 and MM49-30818 to and continued RR45-40885 and RR45-40888 from the agenda.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine sellers applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES - LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

<u>RR49-11398 TRI ENTERTAINMENT CORPORATION</u> – Commission added this permit to the agenda by consent.

Chair Allen noted the Commission approved an extension for this permit at the March 5, 2024 meeting. The permittee filed a corrective action plan regarding the violations that were filed. Over the weekend, there was a shooting at the premises where one person was killed, and five others injured. Chair Allen reached out to the permittee who was devastated by the events, and he informed the Chair the business is closed, and he will be asking that the permit be placed into escrow.

Commissioner Maginn moved to rescind the extension and to place the permit in escrow. Commissioner Jones seconded because the permittee is closing the business permanently and is requesting escrow. The motion was unanimously approved.

Vice Chairman Payne stated currently we do not have all the facts regarding this incident, but we will in the future. There have been other recent events at other establishments and hopefully when we receive all of the information, we will be better able to help alleviate the problems that keep happening.

RR67-40815 DRS PROPERTY, LLC – Chair Allen noted this is a request for catering hall designation.

Commissioner Maginn moved to approve the requests for a catering hall designation. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-34837 J&J PROMOTIONAL GROUP LLC</u> – Chair Allen noted this is a renewal application with the local board voting 2-1 to deny.

Commissioner Maginn stated the owner did not appear at the local board hearing as required due to past violations. The local board and Commission approved a transfer of this permit (RR4940804 S & B Entertainment LLC) in January 2024. The transferee stated this establishment was going to operate as a location for brunch. However, after Excise visited the location, it appeared to be a club, which is how it has been operating, which gives the appearance there has been some intentional misleading of the local board and the Commission as to the operation. There is also an indication that the transferee may be using promoters during business operations.

Commissioner Maginn moved to uphold the local board's denial of the renewal and to also reverse the approval of the transfer. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-040679 O FRESH FOOD LLC</u> – Chair Allen noted this is a new application with the local board voting 3-0 to deny for failure to appear at the local board hearing.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new application. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR29-40707 ORCHID NAILS BEAUTY LLC</u> – Chair Allen noted this is a new application with the local board voting 3-0 to deny.

Commissioner Maginn stated the applicant has work experience in salons owned by family members, but no experience with alcohol service. The local board discussion focused more on the fact that the applicant's family has put more money into this business than the applicant, so the board thought there may be problems with the ownership paperwork, but the alcohol laws do not require those who provide financial backing for the business to be listed as owners.

Commissioner Maginn moved to overturn the local board's recommendation and approve the permit for one year. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen stated she expects strict compliance with alcohol laws, specifically pointing out purchasing alcohol from wholesalers and obtaining employee permits and training, if the applicant wants to continue holding this permit.

<u>DL08-33606 MVP FOODS</u>, <u>LLC</u> – Chair Allen noted this is a new application with the local board voting 3-0 to approve.

Commissioner Maginn stated there were remonstrators present at the local board hearing. They love the store, but do not want the alcohol sales.

Commissioner Maginn moved to uphold the local board's recommendation to approve the new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL83-33472 MCCLURE OIL CORPORATION</u> – Chair Allen noted this is a new application with the local board voting 2-2.

Commissioner Maginn stated there were remonstrators at the hearing, but most were competitors.

Commissioner Maginn moved to approve the new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR71-33743 TAVERN ASSOCIATES LLC</u> – Chair Allen noted this is a request for a second extension.

Commissioner Maginn stated this permittee had a pending violation, causing the local board to continue the renewal until the violation was settled. Therefore, a second extension was needed.

Commissioner Maginn moved to approve a second 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

RR82-37803 GLAMOUR & GOWNS, LLC - Chair Allen noted this is a request for a second extension.

Commissioner Maginn stated the permittee was granted a first extension with a tax protest. The tax protest is still attached to this permit. There was mention of Revenue possibly providing a partial clearance of the tax protest.

Commissioner Maginn moved to approve the second extension when the tax protest is completely clear.

Commissioner Jones asked for clarification regarding the motion.

Chair Allen noted the law allows the issuance of one extension if a tax protest is attached to the permit. After speaking with Revenue, the Chair stated Revenue was not aware of the first extension and was not going to provide a partial clearance of the tax protest for the purpose of an additional extension.

Vice Chairman Payne seconded the motion. Chair Allen voted to approve the motion. Commissioner Jones voted not to approve the motion. Motion approved 3-1.

RR71-36368 THE SOCIAL LLC- Chair Allen noted this is an extension request.

Commissioner Maginn stated this permittee had three violations that were settled in 2022 and currently has violation that has not been settled. That violation is for public nuisance and serving a minor.

Commissioner Maginn moved to approve an extension when a corrective action plan is submitted. Commissioner Jones seconded the motion, but added the plan must meet the approval of the Commission before issuance of the extension. The motion was unanimously approved.

<u>RR49-33920 JOELLA'S INDIANAPOLIS CASTLETON IN LLC</u> – Chair Allen noted this is a request for extension.

Commissioner Maginn stated there are ownership issues being worked out.

Commissioner Maginn moved to approve the request for extension. Commissioner Jones seconded. The motion was unanimously approved.

RR22-39401 WILD EGGS OPERATIONS, LLC - Chair Allen noted this is a request for extension.

Commissioner Maginn stated there are ownership issues being worked out.

Commissioner Maginn moved to approve the request for extension. Commissioner Jones seconded. The motion was unanimously approved.

RC27-00050 AMERICAN LEGION 313 – Chair Allen noted this is a request for extension.

Commissioner Maginn moved to approve the letter of extension. Commissioner Jones seconded. The motion was unanimously approved.

RR10-36856 JOELLA'S CLARKSVILLE IN, LLC - Chair Allen noted this is a request for extension.

Commissioner Maginn stated there are ownership issues being worked out.

Commissioner Maginn moved to approve the request for extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR10-31018 DW RESTAURANT HOLDER LLC</u> - Chair Allen noted this is a request for extension. There are ownership issues that are being worked out.

Commissioner Maginn moved to approve the request for extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>TC15124000 WILD BILL'S TOBACCO OF MICHIGAN CITY</u> — Chair Allen noted this establishment holds a tobacco certificate that is soon to expire so the owner is requesting an extension. There are pending violations. The attorney and prosecutor are in negotiations, but the certificate is about to expire. The Chair stated statutes only allow extensions for permits and tobacco establishments hold certificates.

Chair Allen moved to approve a three-week Letter of Authority to allow time for either settlement of the violations or the scheduling of a hearing. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR29-35551 FUJI SUSHI HIBACHI EXPRESS CORPORATION</u> – Chair Allen noted this request for an extension was added by consent.

Commissioner Maginn stated the owner of the permit is out of the country and has not attended the local board hearing regarding the renewal of the permit. The establishment did have a violation in the last renewal period, so attendance is required at the local board hearing.

Commissioner Maginn moved to allow one 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR79-36538 AES TACO LLC</u> – Chair Allen noted this is a request for an extension.

Commissioner Maginn moved to approve a 90-day extension when the tax protest is clear. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-18293 MARIA MONSERRAT AVALOS HERNANDEZ LLC</u> – Chair Allen noted the Marion County Local Board is requesting remand of this renewal that they approved. This is a type 209 permit that requires a certain amount of food sales. The local board would like to investigate the food sales figures further.

Commissioner Maginn moved to remand the renewal. Commissioner Jones seconded. The motion was unanimously approved.

Noteworthy Violations for 3/19/24 Commission Meeting

RR4520186: Shades of Time Inc. (DBA: Shades of Time Cocktails) in Griffith, Lake County. On December 10, 2023, District 1 was notified by the Griffith Police Department of a shooting in the Shades of Time parking lot following a disturbance inside the business. Officer Painter was assigned to investigate and following the review of body cam video, video surveillance, the investigator's reports, and additional calls for service to the business over the past 2 years, a violation for public nuisance was served. The parties have agreed to a \$2,000 civil penalty and a 5-day suspension of the alcohol permit.

RR4928549: Suite 38 Inc. (DBA: Club Limelight) in Indianapolis, Marion County. In the summer of 2023, the Marion County Task Force received complaints from IMPD that underage subjects were frequenting the business. On July 30, 2023, Excise officers conducted an investigation at the business. Officers observed underage patrons pay a security guard to gain entry. A follow up investigation was conducted on October 4, 2023 and again officers observed underage patrons paying money at the front door to enter the business. Violations were written for both incidents. The parties have agreed to a combined \$3,000 civil penalty and a 10-day suspension of the alcohol permit.
