### **MINUTES**

### ALCOHOL AND TOBACCO COMMISSION

### APRIL 16, 2024

### CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, General Counsel Merritt, and Deputy Director Serak were in attendance.

### DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the April 2, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Sixty-two dispositions were submitted with fines totaling \$47,375.00. Commissioner Jones seconded. The motion was unanimously approved.

### HEARING JUDGE'S RECOMMENDATIONS

<u>BR1957763 RIC HUDDLESTON</u> – Vice Chairman Payne stated this employee permit holder has been convicted of two, unrelated OWIs in the last ten years. Prosecutor Wignall cited him for a violation and offered revocation, because the permittee is not eligible to hold the permit. The permittee appealed and the matter was set for hearing. The Hearing Judge now submits the Proposed Findings of Fact and Conclusions of Law for consideration by the Commission.

Vice Chairman Payne moved to revoke the employee permit because the permittee is not currently eligible to hold the permit. Commissioner Jones seconded. The motion was unanimously approved.

### CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Permit #WH19-30126 was removed from the Commission agenda.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if

needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

### WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

### ITEMS FOR DISCUSSION

<u>RR84-40872 AND RR84-40873 WTH CLUB KOYOTE LLC</u> – Chair Allen noted this was continued from the March 5<sup>th</sup> meeting. These are new applications with the local board voting 3-1 to deny.

Commissioner Maginn stated the Commission had several legal questions concerning this matter from the March meeting, which led to the continuance. Those questions being:

- -Can someone create a new corporate entity to avoid the implications of another law?
- -Does the law only apply to the specific permit applicant corporate entity or also, to the people with an interest in the corporate entity?
- -Does the Commission waive its authority to deny an application for a special disqualification by accepting a permit application and setting it for local board?
- -Does the law foreclose the local board and the commission from considering application qualification?

Commissioner Maginn stated that General Counsel Merrit provided responses to the questions as follows: a new entity cannot be created to avoid the law, the law applies to both corporate entities and to people with interest in a corporate entity, the commission has the ability to deny an application after accepting and setting it for local board, and nothing in our rules prevents a local board or the commission from considering whether a permit applicant meets the eligibility requirements for a particular type of permit.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new applications. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR72-41078 AND RR72-41079 JAVA STATION, INC.</u> – Chair Allen noted these are new applications with the local board voting 3-0 to approve. A remonstrator was present at the local board.

Commissioner Maginn stated the remonstrator who was present is the father of a competitor.

Commissioner Maginn moved to uphold the local board's recommendation to approve. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>DL10-33574 UTICA LIQUORS LLC</u> – Chair Allen noted this is a new application with the local board voting 4-0 to approve.

Commissioner Maginn stated the applicant has pending felony charges against him, but no convictions. A remonstrator was present who is against liquor store permits.

Commissioner Maginn moved to uphold the local board's recommendation to approve the new permit. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR79-40654 FLAMING KUMA, INC.</u> – Chair Allen noted this is a new application with the local board voting 4-0 to deny.

Commissioner Maginn stated the applicant failed to appear multiple times at the local board hearing, as required.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL83-33588 CASEY'S MARKETING COMPANY</u> – Chair Allen noted this is a new application with the local board voting 4-0 to deny.

Commissioner Maginn stated there were two remonstrators present, who are competitors. The remonstrators did submit petitions from residents with over 160 signatures. Cayuga has a population of just over 800.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>TC15124000 WILD BILL'S TOBACCO OF MICHIGAN CITY</u> – Chair Allen noted this certificate is expired and has a pending violation. The Commission granted a letter of authority at the last meeting to allow an opportunity for a possible settlement of the violation. There is a hearing date set for June 13<sup>th</sup> at 10 am.

Chair Allen moved to grant a 90-day letter of authority to allow time for the violation to be settled. Commissioner Maginn seconded. The motion was unanimously approved.

<u>DL10-22088 KROGER LIMITED PARTNERSHIP I</u> – Chair Allen noted this is an extension request.

Commissioner Maginn stated the property tax clearance has not been submitted and the first extension is expiring.

Commissioner Maginn moved to approve a second 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR84-01881 GREG A WILSON</u> – Chair Allen asked that this permit be placed on the agenda by consent. It is a request for an extension.

Commissioner Maginn stated the renewal of this permit was denied. An appeal was filed. A prehearing conference was held and there was an indication a request for remand was to be submitted. An additional prehearing conference is scheduled for 5/2/24, to check the status.

Commissioner Maginn moved to grant a 90-day extension and to place this matter back on the agenda for 5/8/24, if the request for remand has not been received. Vice Chairman Payne seconded.

Commissioner Jones asked if the motion to remand will come before the full Commission, or just Vice Chairman Payne, as hearing judge in the matter. Chair Allen stated procedurally it would come before the full Commission, with a recommendation from the Vice Chairman after the 2<sup>nd</sup> prehearing.

After the discussion, an amended motion that includes the full Commission to consider the remand on 5/8/24 was unanimously approved.

<u>RR79-31747 CENTRAL FLORIDA RESTAURANTS INC.</u> – Chair Allen asked this be added by consent.

Chair Allen stated the permit is expired, but renewals are on file. The renewal could not be issued due to a tax hold. The permit has been non-operational in escrow. They would like to file a transfer. The Commission has received the most recent clearance of the tax hold.

Chair Allen moved to reactivate the permit. Commissioner Maginn seconded. The motion was unanimously approved.

### Noteworthy Violations for 4/16/24 Commission Meeting

RC8423902: Amvets Post 222 Inc. (DBA: Amvets Post 222) in West Terre Haute, Vigo County. On October 22, 2023, Vigo County Sheriff's Department officers were called to the club on a report of shots fired. It was determined an unknown suspect opened fire inside a crowded dance hall area, hitting two people. Further investigation led to information that the club allowed a promoter to host an event inside during Indiana State University's Homecoming weekend. On the night of the incident, the building was over capacity and a back door was propped open allowing patrons to enter without passing through security. A violation for public nuisance was written for the club. The parties have agreed to a \$1,000 civil penalty and a 3-day weekend suspension of the alcohol permit.

RR7136368: The Social LLC (DBA: Cheers Pub) in Roseland, St. Joseph County. In the fall of 2023, District 1 received a complaint that the business was allowing minors into the premise. Officer Joe Formato was assigned and on November 2, 2023 an enforcement detail with local police departments was conducted. Officers cited 64 minors inside the business, 30 of which were known to have possessed or consumed alcoholic beverages. A member of the security staff was identified as someone who would allow minors to enter by paying cash. Violations were written for public nuisance, furnishing alcohol to a minor, and minors in a tavern. The parties have agreed to a \$2,000 civil penalty, a 3-day weekend suspension of the alcohol permit, and the business has been placed on the PACE program.

RR8437356: Snacks Café Inc. (DBA: Snacks Café) in West Terre Haute, Vigo County. On January 20, 2024, District 5 Officer Marty Workman conducted a permit visit at the business. During this visit, Officer Workman identified bottles of liquor that did not come from a distributor. Further investigation led to invoices showing alcohol was being bought from numerous retail locations. This was the third violation for Snacks Café for purchasing alcohol from a retailer. The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the alcohol permit.

RR4939406: The Daquiri Factory LLC (DBA: The Daquiri Factory) in Indianapolis, Marion County. During the summer of 2023, District 6 received complaints regarding the business practices of the Daquiri Factory. They were assigned to Officer Rich Swallow and led to two separate permit visits and violation reports. Violations were found for illegal carry-out, disclosure of interested parties, minimum food requirements, floor plan alterations, hinderance, dealing unauthorized beverages, original container issues, among others. At the time, the new permittee did not seem to understand many of the rules and regulations required to hold a retail restaurant permit. The parties have agreed to a combined \$4,000 civil penalty and a 3-day suspension of the alcohol permit.

## REQUEST FOR COMMISSION TO REVIEW RECOMMENDATION OF LOCAL BOARD

Comes now the permittee, by counsel, and hereby requests the Commission for additional review of the February 26, 2024 recommendation of the Local Alcoholic Beverage Board of Vigo County to deny the application for the new permits in West Terre Haute, Indiana in this matter. In support of this request, the permittee would show the Commission the following:

- 1. Permittee received a 3-1 vote to recommend denial of its application for the new permits herein. The vote to approve was from State Excise Police Officer Brad Lutes.
- 2. The permittee applicant herein is an Indiana limited liability company whose sole member is Swapanjit S. Vander of Terre Haute, Indiana.
- 3. Mr. Vander was also the sole member of CODA Enterprises LLC, which unsuccessfully sought to transfer Permit Nos. RR84-20633 and RR84-20634 which were given new permit numbers RR84-39967 and RR84-39968.
- 4. On or about October 16, 2023, the LB voted 4 0 to recommend denial of the transfer from Top Hat, Inc., to CODA Enterprises LLC.
- 5. As the sole member of CODA Enterprises LLC, and given the tumultuous history of the Top Hat permits before the LB and the Commission, Mr. Vander declined to appeal the decision of the LB to recommend denial of the transfer, and decided to obtain his own permits as at the time, there were four (4) permits available in West Terre Haute that would allow for a Type 210-1 to operate at the permit location, if approved by the Commission.
- 6. Mr. Vander then formed the instant permittee limited liability company for purposes of applying for the instant permits.
- 7. When the application for the instant permits was filed with the Commission in late December, 2023, the above matters regarding the October, 2023 transfer denial were fully disclosed to the Commission.

- 8. The Commission accepted permittee's applications and referred the matter to the Vigo County LB.
- 9. The LB's recommendation of denial for the sole reason that Mr. Vander was a member of an LLC that was denied a transfer of a permit in October, 2023 for reasons wholly unrelated to the instant permit was an unwarranted intrusion into the Commission's authority to accept the applications and its decision under the circumstances to allow the new permit applications to be heard by the LB in the first place.
- 10. Whether Mr. Vander was a member of an LLC that within the past year had a transfer permit rejected for different reasons unrelated to the instant matter was not a factual issue requiring input from the LB.
- 11. The LB's inquiry was limited to whether Mr. Vander was a fit and proper person to hold an alcoholic beverage permit, had a good reputation in the community and otherwise met the qualifications to hold the permit.
- 12. The LB's recommendation does not fit within the parameters of 905 IC 1-30-27 regarding what the LB can consider when determining whether to recommend approval of a permit application.
- 13. There were no remonstrators against the permittee and no members of the community voiced opposition to these applications.

WHEREFORE, the permittee requests that the Commission remove this matter from the March 5, 2024 Commission agenda if necessary; that it examine the LB's recommendation in detail; that it refer, if necessary to the October 16, 2023 LB hearing denying transfer for CODA Enterprises LLC; and that it reverse the LB's February 26, 2024 recommendation to deny the permit and that it grant the applications in this matter.

### I. Introduction

On March 5, 2024, the Indiana Alcohol and Tobacco Commission ("ATC" or "Commission") considered the recommendation of the Vigo County Local Alcoholic Beverage Board ("Local Board") regarding the above-referenced permit applications submitted by WTH Club Koyote, LLC ("Applicant"), as well as the Applicant's Request for Commission to Review Recommendation of Local Board filed with the Commission by attorney Mark Webb following the local board hearing. Due to legal arguments contained in the Applicant's request, the Commission voted to continue its consideration of the Applicant's permit applications, and asked ATC legal staff for its opinion on the questions presented below.

### II. Facts

### A. Top Hat, Inc. (RR84-20634)

Michael Bickers is a resident of the state of Illinois and the owner of real property located at 121 East Paris Avenue in West Terre Haute, Indiana. Previously, a beer, wine, and liquor retailer permit was issued to Top Hat, Inc. at this address. At the time the permit was initially issued, Indiana law prohibited the issuance of a retailer permit to a corporation unless sixty percent (60%) of the stock held in the corporation was owned by persons who had been continuous and bona fide residents of Indiana for at least five (5) years¹. As owner of the property, Mr. Bickers acted as a landlord and rented the property to Top Hat, Inc. for purposes of operating an adult entertainment venue. At that time, Top Hat, Inc. was owned by Joseph Downing (60%) and Denise Wilhoit (40%), respectively. Joseph Downing was an Indiana resident, and Denise Wilhoit was an Illinois resident.

Later, it was discovered that Mr. Bickers held an undisclosed interest<sup>2</sup> in the permit (or the business conducted under it) due to his "common law" marriage to Ms. Wilhoit<sup>3</sup> and evidence that he and the permit holder were engaged in business practices that went

beyond a landlord-tenant relationship<sup>4</sup>. However, this interest was never disclosed on any permit renewal application paperwork. On December 19, 2022, the Vigo County local alcoholic beverage board voted 3-0 in favor of denying the permit renewal application due to Mr. Bickers' undisclosed interest. On January 18, 2023, the Commission upheld the local board's recommendation and denied the renewal application submitted for Top Hat, Inc.

After appealing the denial of its permit renewal application, Top Hat, Inc. requested permission to transfer the permit in an arms-length transaction to a new owner in lieu of proceeding with an appeal hearing. The Commission granted Top Hat Inc.'s request, and the administrative appeal was dismissed.

### B. CODA Enterprises, LLC (RR84-39968)

On March 30, 2023, an application for a transfer of ownership was submitted for the permit by CODA Enterprises, LLC with Christopher Smith and Dalton Smith listed as its members. Later, for unknown reasons, Christopher Smith decided to sell CODA Enterprises, LLC and the alcohol permit to Swapanjit Vander, at which time the transfer application paperwork was updated to reflect Mr. Vander as the new sole owner of CODA Enterprises, LLC.

Despite Mr. Vander's best efforts, he was unable to provide a signed purchase agreement or otherwise demonstrate that the previous owner of the permit, Joseph Downing, consented to the transfer of the permit to CODA Enterprises, LLC. As such, on October 16, 2023, the local board voted to deny the permit transfer application. Later, on November 8, 2023, the Commission upheld the local board's recommendation and denied the permit transfer. CODA Enterprises, LLC did not submit an appeal request for the denial of its permit transfer application.

### C. WTH Club Koyote, LLC (RR84-40872 / RR84-40873)

Following the permit denial of CODA Enterprises, LLC, Mr. Vander established a new business entity, WTH Club Koyote, LLC. On December 29, 2023, a new permit application for a beer, wine, and liquor permit was submitted by WTH Club Koyote, LLC, and the application listed the permit address as 121 E. Paris Avenue in West Terre Haute—the same location where Mr. Bickers owns property. Once again, Mr. Bickers was not disclosed as having an interest in the permit on the application paperwork, but counsel for the Applicant did submit a written explanation regarding the nature of his business relationship with the Applicant. In short, the Applicant argues that Mr. Bickers is not required to be disclosed on the permit application because he has no ownership interest in the permit, and only acts as a landlord of the premises. Attached is a copy of the purported lease agreement between Mr. Bickers and the Applicant which was submitted to ATC General Counsel upon request.

On February 26, 2024, a local board hearing was held on the new permit application. At the hearing, counsel for the Applicant argued that because the Commission accepted its permit application for filing, the previous denial of CODA Enterprises, LLC's application

does not disqualify it from obtaining a permit. Ultimately, the local board voted 4-0 to deny the Applicant's new permit application, citing the previous issues with Mr. Bickers' undisclosed interest. Afterwards, counsel for the Applicant filed a Request for Commission to Review Recommendation of Local Board and asked the Commission to re-examine the local board's decision. On March 5, 2024, the Commission voted to continue its consideration of the permit application until a later date so that legal staff could address the questions below.

### III. Questions Presented

- A. Can someone create a new corporate entity to avoid the implications of IC 7.1-3-4-2(a)(13)?
- B. Does IC 7.1-3-4-2(a)(13) only apply to the specific permit applicant corporate entity or also to the people with an interest in the corporate entity?
- C. Does the Commission waive its authority to deny an application for a special disqualification by accepting a permit application and setting it for local board?
- D. Does 905 IAC 1-27 foreclose the local board and the commission from considering application qualification issues in Title 7.1?

### IV. Brief Answers

- A. No, a new corporate entity cannot be created in order to avoid a special disqualification set forth in IC 7.1-3-4-2. Taking any action—including creating a new business entity—in order to avoid a special disqualification is attempting to do something indirectly that is directly prohibited by law.
- B. Both. Permittees are required to possess all of the requisite qualifications to hold a particular type of permit, and each manager and member of a limited liability company must possess all other qualifications required of an individual applicant for that particular type of permit.
- C. No. The Commission has the discretionary authority to issue, deny, suspend, revoke, or not issue a permit or certificate issued under Title 7.1 of the Indiana Code.
- D. No. Nothing contained in 905 IAC 1-27 prevents or forecloses a local board or the Commission from considering whether a permit applicant meets the eligibility requirements for a particular type of permit.

### V. Legal Authority & Analysis

A. IC 7.1-3-4-2(a)(13) states that the Commission may not issue a permit to a person<sup>5</sup> who has made an application for a permit of any type which was denied less than one (1) year prior to the person's application for a beer retailer permit (unless the previous application was denied by reason of a procedural or technical defect). According to IC 7.1-1-2-5, whenever a person<sup>6</sup> is prohibited from doing a certain act or holding a certain interest directly, he or she shall also be prohibited from doing that act or holding that interest indirectly. As such, a person that is prohibited from directly obtaining or holding a permit due to a special disqualification cannot hold an indirect interest in a permit.

In this case, Mr. Vander took over CODA Enterprises, LLC in May 2023 as its sole member. Afterwards, the local board voted to deny its permit transfer application because it was unable to provide a signed purchase agreement between the parties, and there was insufficient evidence that Top Hat, Inc. or Joseph Downing, the corporation's sole remaining shareholder, consented to the transfer of the permit. The Commission upheld the local board's decision and denied the transfer application on November 18, 2023. Accordingly, under IC 7.1-3-4-2(a)(13), CODA Enterprises, LLC is disqualified from holding a permit for one (1) year from the date that CODA Enterprises LLC's application was denied by the Commission. Similarly, Mr. Vander is also disqualified from holding a permit for one (1) year from the date that CODA Enterprises LLC's application was denied, regardless of whether he applies individually or under a new business entity, because he had an interest in the denied permit application.

B. Pursuant to IC 7.1-3-23-12, the Commission may revoke the permit of a permittee if it ceases to possess any of the qualifications required to hold a particular type of permit. Similarly, according to IC 7.1-3-21-5.4, each manager and member of a limited liability company (LLC) must also possess all other qualifications required of an LLC as permit holder. When read together, these statutes indicate that a permit qualification (or disqualification) applies to a corporate entity as the permit applicant, as well as the individuals with an interest in the corporate entity.

In this case, both WTH Club Koyote, LLC and Mr. Vander, as the sole LLC member, must possess the necessary qualifications to hold the permit. This means that the special disqualification set forth in IC 7.1-3-4-12(a)(13) prohibits the Commission from issuing a beer retailer permit to any person<sup>7</sup> that has been denied a permit in the previous year, including WTH Club Koyote, LLC as a permit applicant and Mr. Vander as the LLC's sole member.

C. Under IC 7.1-2-3-9, the Commission has the discretionary authority to issue, deny, suspend, revoke, or not renew all permits and certificates authorized by Title 7.1 unless

its exercise of discretion or authority is limited by applicable provisions of Title 7.1. According to the Indiana Supreme Court, implied within this power is also a duty to act. In other words, because the ATC is the sole governmental agency in Indiana that is authorized to issue alcohol permits, it has a statutory duty to act upon each permit application by either approving it or denying it. With that being said, accepting a permit application for filing and setting it for a local board hearing does not negate the Commission's discretionary authority to issue or deny the application because it is statutorily required to take action on it and it is the only agency in Indiana that can do so.

In this case, the Commission was complying with its statutory duty to act when it accepted the completed permit application for WTH Club Koyote, LLC. Additionally, the acceptance of a completed permit application also ensures that applicants and permittees are able to exhaust their administrative remedies and helps ensure that the agency maintains public records in accordance with the Indiana Access to Public Records Act (APRA).

D. IC 7.1-3-4-2(a)(2) states that the Commission may not issue a beer retailer permit to a person who is not of good repute in the community in which the person resides. To that end, 905 IAC 1-27-1 provides the following:

"In determining an applicant's or permittee's eligibility to hold, renew or continue to hold a permit, *particularly whether the applicant is of good moral character and of good repute*, the Commission shall consider whether acts or conduct of the applicant, permittee or his employees or agents, would constitute action or conduct prohibited by the Indiana Penal Code (I.C. 35-41-1-1 et seq.), or a criminal offense under the laws of the United States. The Commission may also consider the esteem in which the person is held by members of his community, and such assessment of his character as may reasonably be inferred from police reports, evidence admitted in court and commission proceedings, information contained in public records and other sources of information as permitted." (emphasis added).

When reviewing the statute and rule together, it's clear that the purpose of the administrative rule is to provide guidance regarding what type of evidence the Commission may consider when it determines whether an applicant or permittee is subject to the special disqualification set forth in IC 7.1-3-4-2(a)(2). In other words, the rule expands upon what the Commission may consider when determining whether the applicant or permittee is of good repute, and is intended to supplement the statute. Given this context and the plain language of the rule itself, nothing contained in 905 IAC 1-27 prevents or forecloses the Commission (or a local board) from considering whether a permit applicant meets the eligibility requirements for a particular type of permit.
