#### **MINUTES**

#### ALCOHOL AND TOBACCO COMMISSION

JUNE 4, 2024

#### CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, General Counsel Merritt, and Deputy Director Serak were in attendance.

#### DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the May 21, 2024 meeting. Commissioner Maginn seconded. The motion was unanimously approved.

#### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Forty-five dispositions were submitted with fines totaling \$33,100.00. Commissioner Maginn seconded. The motion was unanimously approved.

Chair Allen made note that tobacco distributors are required to be licensed by the Department of Revenue. Tobacco retailers should make sure they are purchasing from licensed distributors because the Commission does not tolerate the sale of counterfeit products.

#### **CONSIDERATION OF APPLICATIONS**

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Vice Chairman Payne seconded. The motion was unanimously approved.

#### WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

#### ITEMS FOR DISCUSSION

<u>DL55-13483 EWRW CORPORATION</u> – Chair Allen noted this is a renewal with the local board voting 3-1 to approve.

Commissioner Maginn stated there were no remonstrators. The permittee had a violation for furnishing alcohol to a minor that was settled and the fine paid. The local board member voted to deny because of the particular violation of furnishing alcohol to a minor.

Commissioner Maginn moved to uphold the local board's recommendation to approve the renewal. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR82-94324 O'CHARLEY'S LLC</u> – Chair Allen noted this is a conversion from a type 209 permit to a type 210 permit due to annexation.

Commissioner Jones stated that the annexation occurred in 2008. The permit was issued in 1994. Based on statute, this permit qualifies to be converted to a type 210 permit.

Commissioner Jones moved to approve the conversion. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>DL45-31644</u>, <u>DL45-31642</u>, <u>DL45-31643</u> <u>SPURLOCK LIQUORS</u> – Chair Allen noted these are 2<sup>nd</sup> extension requests.

Commissioner Maginn stated the owner passed away and paperwork is in the process of being filed to correct the ownership.

Commissioner Maginn moved to approve the extension requests. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-36274 NITE OWLS LLC</u> - Chair Allen noted this is a second extension request added to the agenda by consent.

Commissioner Maginn stated this request came in at the last minute and there was not adequate time to review the paperwork. The current extension expires on June 18th, which is the date of the next commission meeting.

Commissioner Maginn moved to continue this request to the June 18<sup>th</sup> meeting. Commissioner Jones seconded. The motion was unanimously approved.
