ALCOHOL AND TOBACCO COMMISSION

JULY 16, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Staff Attorney Beaucaire were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the July 2, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Forty-four dispositions were submitted with fines totaling \$25,100.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Chair Allen asked the Commission to remove permit #RR45-01021 from the agenda by consent. The renewal was signed by someone not on the ownership or management of record, so more investigation is needed.

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

<u>RR49-03006 DEER-BELL INC.</u> – Chair Allen noted this is a renewal application with the local board voting 4-0 to deny.

Commissioner Maginn stated that this establishment has a history of violations that include prostitution, nudity, falsification of records, and public nuisance. The owner is looking to sell the business to someone who appears to be connected to other businesses that have had problems with us in the past.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>DL50-33638 VARDAAN INC.</u> – Chair Allen noted this is a new application with the local board voting 4-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR71-41077 MANJARES DE MEXICO RESTAURANT LLC</u> – Chair Allen noted this is a new application with the local board voting 3-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL79-32798</u> 6TH ST MARKET INC. – Chair Allen noted this is a request for remand.

Commissioner Maginn stated this permittee has a pending violation. The permittee, at the local board hearing, stated the violation had been settled so the renewal was voted on by the board. However, the violation has not been settled, so the local board has requested the renewal be remanded for investigation.

Commissioner Maginn moved to approve the request for remand. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR45-38660 TGGR CP HOLDINGS LLC</u> – Chair Allen noted this is on for discussion following denial of escrow after two failures to appear.

Commissioner Maginn stated the permittee sent a notice stating that they had failed to open their mail due to severe health issues and hospice care. They are asking for one more opportunity to appear at an escrow hearing.

Commissioner Maginn moved to allow one more opportunity to appear. Commissioner Jones seconded. The motion was unanimously approved.

Commissioner Jones noted that this goes beyond not opening mail. There was a family member in hospice care that required a lot of time and attention. It was not just a matter of ignoring mail.

<u>RR49-35291 TEQUILA'S MEXICAN RESTAURANT & BAR LLC</u> – Chair Allen noted this is on for discussion following denial of escrow after two failures to appear.

Commissioner Maginn stated this permittee was denied escrow for failure to appear at two hearings.

Commissioner Maginn moved to deny renewal of the permit. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-32402, RR29-32621, RR10-35173, RR29-32215 WILD EGGS OPERATIONS LLC - Chair Allen noted these are requests for second extensions.

Commissioner Maginn stated there are property tax and ownership issues with this permittee that are being worked out.

Commissioner Maginn moved to approve a second extension for all four permits. Commissioner Jones seconded. The motion was unanimously approved.

RR84-01881 GREG WILSON- Chair Allen noted this permittee is requesting a second extension.

Commissioner Maginn stated the renewal was remanded to the local board. The local board continued the hearing, so the current extension is expired.

Commissioner Maginn moved to approve the second extension. Commissioner Jones seconded. The motion was unanimously approved.

RR45-20186 SHADES OF TIME INC. - Chair Allen noted a second extension request has been filed.

Commissioner Maginn stated the local board denied renewal of this permit and the Commission upheld that denial. The Griffith Police Department remonstrated at the local board hearing. A corrective action plan has not been filed and there is a tax protest on file.

Commissioner Maginn moved to deny the request for a second extension. Commissioner Jones seconded. The motion was unanimously approved.

Noteworthy Violations for 7/16/24 Commission Meeting

<u>TC14146001</u>: Brazil BP Inc. in Brazil, Clay County. On May 6, 2024, District 5 Officer Marty Workman conducted a premise inspection at the business. During the inspection, Officer Workman located counterfeit Mr. Fog Max and Mr. Vapor Maxx products for sale. The store did not have invoice records for the items, nor any information about where the products came from and in total 26 vape devices were seized. **The parties have agreed to a \$1,500 civil penalty and a 30-day suspension of the tobacco certificate.**

<u>TC15908002</u>: Indy Smoke Shop LLC in Plainfield, Hendricks County. The District 3 Excise office received multiple complaints regarding the business selling tobacco and vape products to underage subjects. On April 15, 2024, Officer Alex Vargo observed a 16-year-old purchase tobacco products. Additionally, on April 27, 2024, Officers Richard Helck and Alex Vargo observed the business sell cigars to a 19-year-old male. The same clerk was involved in both incidents. These violations represented the third and fourth times the business has been caught by Excise officers selling tobacco products to underage subjects. **The parties have agreed to a combined \$2,000 civil penalty and a combined 10-day suspension of the tobacco certificate.**

<u>TC13680001</u>: AN1629 Inc. (DBA: Marathon) in Anderson, Madison County. On May 11, 2024, District 6 Officers Melissa Krieg and Matt Snyder conducted a tobacco compliance check at the business. During this check, the on-duty clerk sold a can of smokeless tobacco to the youth without checking any identification or requesting a date of birth. This was the third violation for sale of tobacco to a minor in the past two years. **The parties have agreed to a \$1,500 civil penalty and a 3-day suspension of the tobacco certificate.**

<u>TC12881001</u>: Anderson Pantry Inc. (DBA: Anderson Pantry) in Anderson, Madison County. On May 16, 2024, District 6 Sgt. Chuck Peters and Officer Brandon Reynolds conducted a tobacco compliance check at the business. During this check, the on-duty clerk sold a package of cigarettes to the 17-year-old youth without asking for identification or requesting a date of birth. This was the third violation for sale to a minor at the business. **The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the tobacco certificate.**
