ALCOHOL AND TOBACCO COMMISSION

AUGUST 6, 2024

**CALL TO ORDER/NOTING OF QUORUM**

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

**DISPOSITION OF MINUTES**

Vice Chairman Payne moved to approve the minutes from the July 16, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

**PROSECUTOR'S RECOMMENDATIONS**

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Sixty-seven dispositions were submitted with fines totaling \$36,200.00. Commissioner Jones seconded. The motion was unanimously approved.

**HEARING JUDGE'S RECOMMENDATIONS**

RR07-40473 HARMONY TREE RESORTS, INC. – Vice Chairman Payne, who sat as hearing judge in this matter, stated this was a denied application with an appeal filed. A neighbor, along with her 8-year-old daughter were the remonstrators present. Testimony and exhibits were presented.

The applicant noted this business is being promoted as a restaurant/bar for glampers who are camping nearby. There is an additional establishment that is nearby, but up a winding road on a steep hill. The applicant feels this new business would be more convenient for the glampers. The proposed business is next to a residence and is in plain sight of an 8-year-old's bedroom. Other remonstrators were present at the local board hearing, but not at the appeal hearing. The Hearing Judge noted that Brown County is generally known to be quaint, and it draws people for the nature and friendliness of the community. The Hearing Judge now submits Proposed Findings of Fact and Conclusions of Law for consideration by the Commission.

Vice Chairman Payne moved to uphold the Commission's denial of the new permit.

Commissioner Maginn stated objections were filed by the applicant. In the objections the applicant stated he was willing to build a berm or fence to block the business from the young girl's bedroom. Petitions were included with the objections.

Commissioner Maginn moved to approve the new permit.

Commissioner Jones would second, however, he wanted the applicant to honor the building of the barrier/berm.

Commissioner Maginn moved to amend the motion to include requiring the applicant to keep to his word about building the barrier/berm. Commissioner Jones seconded. Chair Allen voted to approve. Vice Chairman Payne voted no.

Motion approved 3-1 to approve the new permit.

### **CONSIDERATION OF APPLICATIONS**

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

The commissioners added permit #CT49-32564 to the agenda by consent.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

### **WAIVERS OF FEES – LETTERS OF EXTENSION**

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

### **ITEMS FOR DISCUSSION**

DL20-11316 STERLING AVENUE LIQUOR STORE, INC. – Chair Allen noted this is on for a request to reactivate the permit.

Commissioner Maginn stated this permit was sold on contract in 2005, but never transferred. The corporation was dissolved with the Secretary of State and the permit was made dead because Sterling Avenue Liquor Store, Inc., did not keep the permit active. The request is for reactivating the permit, placing it in escrow and transferring it.

Commissioner Maginn moved to approve the request, but with the understanding that everything must be completed in 90 days---all paperwork filed, fees paid, and transfer completed. The motion also included this matter be placed on the November 6, 2024 agenda for review. Commissioner Jones seconded.

Chair Allen stated if a permittee sells a permit on contract without transferring it, the permit holder is still responsible for the permit.

The motion was unanimously approved.

RR33-41027 SOAAMI REALTY LLC – Chair Allen noted this is a request to convert a type 209 permit to a type 210 permit

Commissioner Maginn moved to approve the conversion. Commissioner Jones seconded. The motion was unanimously approved.

RR41-16326 VALLE VISTA GOLF CLUB & CONFERENCE CENTER– Chair Allen noted this is a request to convert a type 209 permit to a type 210 permit

Commissioner Maginn moved to approve the conversion. Commissioner Jones seconded. The motion was unanimously approved.

RR02-41437 SIMPLY ELEGANT RENTALS LLC – Chair Allen noted this is a request for a catering hall designation.

Commissioner Maginn moved to approve the catering hall designation. Commissioner Jones seconded. The motion was unanimously approved.

RR02-TAQUERIA EL RANCHITO LLC – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated this permittee had a violation that has been settled and a tax protest that has been cleared. They are now requesting a second extension because the local board hearing has not been held regarding the renewal.

Commissioner Maginn moved to approve the extension request. Commissioner Jones reluctantly seconded due to the fact that the extension request did not provide a detailed reason for the request, just that it was needed. The motion was unanimously approved.

DL79-32798 6<sup>TH</sup> ST MARKET INC – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated this permittee had two violations that have now been settled. The local board had to be continued due to the violations.

Commissioner Maginn moved to approve the request for extension. Commissioner Jones seconded. The motion was unanimously approved.

RR29-37566 SUCCESS FOODS MANAGEMENT GROUP LLC – Chair Allen noted this is on for an extension request.

Commissioner Maginn moved to approve the request. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones stated if renewals were filed timely, the extension might not have been needed.

RR32-34389 NEW UGLY CRAB LLC - Chair Allen noted this is on for an extension request.

Commissioner Maginn moved to approve the request. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones stated if renewals were filed timely, the extension may not have been needed.

DL49-31056 LIQUOR DEPOT LLC - Chair Allen noted this is on for an extension request, following a previously denied escrow request at our last meeting.

Commissioner Maginn stated they had two violations that had not been settled at our last meeting and a corrective action plan was not filed, so the request for extension was denied. The violations are now settled and a corrective action plan with amendments was submitted. Commissioner Maginn noted that she feels this permittee is lacking in the basic knowledge of the alcoholic beverage laws. She suggested that counsel should reach out and make sure the permittee gains the knowledge needed to run this business.

Commissioner Maginn moved to approve the request for a second extension. Commissioner Jones seconded the motion and the suggestion.

Chair Allen stated in the corrective action plan a photo was included showing the signage that is posted. However, the sign states "No smoking within 6 feet of the door", not 8 feet as required by the Smoke-Free Air Law. The Chair asked for the motion to be amended to not issue the extension until there is proof of proper signage posted at the establishment.

Commissioner Maginn moved to approve the amendment. Commissioner Jones seconded. The amended motion was unanimously approved.

RR29-33404 CARMEL AGAVE BAR & GRILL – Chair Allen noted this is on for an extension request, added by consent of the Commission.

Commissioner Maginn moved to approve a fee-waived extension, due to scheduling errors. Commissioner Jones seconded. The motion was unanimously approved.

Vice Chairman Payne moved to make 15 permits dead. Commissioner Jones seconded. The motion was unanimously approved.

Melissa said she is looking forward to working with us.





## **Noteworthy Violation for 8/6/24 Commission Meeting**

RR4933618: Johalron Inc. (DBA: India Palace) in Indianapolis, Marion County. In April 2024, the Marion County Task Force began investigating due to a reported shooting at the business. It was determined one person was shot and that multiple casings were found in the parking lot. The business admitted they rented out their space for an event on the night in question. Upon inspection, there were numerous other issues to include: falsification of records, dealing in unauthorized beverages, no records of employee permits, floor plan issues, not meeting minimum food requirements, etc. A violation was written for these and additional matters. **The parties have agreed to a \$2,000 civil penalty and a 3-day suspension of the alcohol permit.**
