ORDINANCE No.1388

AN ORDINANCE ESTABLISHING A DESIGNATED OUTDOOR REFRESHMENT AREA WITHIN THE TOWN OF SPEEDWAY, INDIANA

WHEREAS, I.C. §7.1-3-31 authorizes the establishment of a Designated Outdoor Refreshment Area;

WHEREAS, the Town Council of the Town of Speedway, Indiana ("Town Council") believes it is in the best interests of the Town of Speedway ("Town") to create a Designated Outdoor Refreshment Area ("Refreshment Area") in the Town's Main Street area, as authorized by I.C. §7.1-3-1 *et seq.*, which Refreshment Area is shown on the map marked as Exhibit A attached hereto and incorporated herein.

THEREFORE, IT IS ORDAINED by the Town Council of the Town of Speedway as follows:

- 1. All definitions in I.C. §7.1-3-31 et seq. shall apply to this Ordinance;
- 2. The Town Council hereby adopts the map of the Speedway Main Street Designated Outdoor Refreshment Area attached hereto as Exhibit A and incorporated herein by reference;
- 3. The Speedway Main Street Designated Outdoor Refreshment Area boundary by streets is as follows:

The DORA boundary is generally the area from the alleyway on the west side of Main Street to the sidewalk on the east side of Main Street starting from W. 16th Street and proceeding south to 10th Street. There are a few deviations from this as there is a larger area included behind and to the west of Foyt Wine Vault, Daredevil Brewing, and Speedway Indoor Karting. On the map, several specific businesses are shown including locations such as O'Reilly's Irish Pub & Restaurant, Dawson's on Main, Barbecue and Bourbon, Foyt Wine Vault, Daredevil Brewing, Brozinni's Pizzeria, and Big Woods.

- 4. The Town Council finds that the Speedway Main Street Designated Outdoor Refreshment Area is consistent with the Town of Speedway's Zoning Code;
- 5. The Town Council hereby approves and adopts the minimum signage designating the Speedway Downtown Designated Outdoor Refreshment Area attached hereto as Exhibit B and incorporated herein by reference and directs the Town to place the signage at the designated locations on Exhibit C;
- 6. The Town Council recognizes that additional signage designating the Speedway Main Street Designated Outdoor Refreshment Area may be warranted and necessary, that Exhibits B and C are only minimum standards, and therefore, the Town of Speedway Street Department is

hereby authorized and granted full authority to increase the number or change the type of signage in their sole discretion and in compliance with I.C. § 7.1-3-31;

- 7. The Speedway Main Street Designated Outdoor Refreshment Area shall be in effect during all authorized times pursuant to I.C. §7.1-3-1-14 as amended from time to time by the Indiana General Assembly;
- 8. The following retailer permittees, whose locations are identified on Exhibit A, have submitted a completed application to the Town to participate in the Refreshment Area as a Designated Permittee and the Town finds that each of them is an appropriate Designated Permittee and requests that the Indiana Alcohol and Tobacco Commission issue a Refreshment Area Designation to the following:
 - a. O'Reilly's Irish Pub & Restaurant
 - b. Dawson's on Main
 - c. Barbecue & Bourbon
 - d. Daredevil Brewing
 - e. Foyt Wine Vault
 - f. Speedway Indoor Carting
 - g. Big Woods Speedway

Any additional licensed premises located within the Speedway Main Street Designated Outdoor Refreshment Area who desires to be designated as a Designated Permittee and granted a Refreshment Area Designation shall submit an application, consisting of a completed State Form 57288 Designated Outdoor Refreshment Area Designation Form attached hereto as Exhibit D and incorporated herein, to the Town for approval and recommendation by the Town Council by Resolution;

- 9. Any establishments that desire to be a vendor for an event or festival held within the Speedway Main Street Designated Outdoor Refreshment Area shall submit an application, consisting of a Special Event Permit Application and State Form 57288 Designated Outdoor Refreshment Area Designation Form, to the Town for approval by the Town Council by Resolution;
- 10. A vendor's location may be at any area within the Speedway Main Street Designated Outdoor Refreshment Area as shown on Exhibit A, subject to approval of the Special Event Permit and State Form 57288 Designated Outdoor Refreshment Area Designation Form by the Town Council;
- 11. Nothing in this Ordinance prohibits a business, landlord or other establishment from prohibiting open containers of alcoholic beverages to enter their premises or from prohibiting alcoholic beverages purchased from another establishment to enter their premises;
- 12. The Town maintains full authority and control over the sidewalks, streets and public common areas and no one may prohibit or limit open containers in accordance with I.C. §7.1-3-31 *et seq.* within the Speedway Downtown Designated Outdoor Refreshment Area in those spaces except for the Town of Speedway Police Department;

- 13. In accordance with I.C. §7.1-3-31 et seq., a person may consume an alcoholic beverage purchased from a Designated Permittee or vendor anywhere within the Refreshment Area boundaries, subject to the right of any retailer permittee or business within the Refreshment Area to refuse to allow individuals to enter the licensed premises or business with an alcoholic beverage;
- 14. In accordance with I.C. §7.1-3-31 et seq., all Designated Permittees and vendors may allow a person to exit the Designated Permittee's or vendor's licensed premises with not more than two (2) open containers of an alcoholic beverage at a time. The open containers must be in a plastic cup no larger than sixteen (16) ounces. The contents of an open container may not exceed the following:
 - a. Beer or flavored malt beverage of not more than sixteen (16) ounces.
 - b. Wine, cider or hard seltzer of not more than twelve (12) ounces.
 - c. A mixed drink of not more than ten (10) ounces containing not more than two (2) ounces of liquor.
- 15. A sign, as required by I.C. §7.1-3-31-16 and attached hereto as Exhibit E, must be posted at each exit of a Designated Permittee and on the licensed premises of a vendor;
- 16. Glass containers may only be allowed in a Designated Permittee's outdoor dining area and may not be removed into the Speedway Downtown Designated Outdoor Refreshment Area:
- 17. The Speedway Main Street Designated Outdoor Refreshment Area shall be in effect upon passage until October 31, 2024, and each year thereafter from January 1 through December 31.
- 18. This Ordinance shall be in full force and effect upon its passage and subject to the approval of the Indiana Alcohol and Tobacco Commission.

Map of Town of Speedway Main Street Designated Outdoor Refreshment Area with Location of Designated Permittees Marked



Locations to Place Signage




EXHIBIT D State Form 57288 Designated Outdoor Refreshment Area Designation
