### INSTRUCTIONS:

1. This form is only to be used when enrolled in Driver Education.
2. Complete the form in blue or black ink or print the completed form.
3. An applicant must receive a score of eighty (80) percent or higher in the theoretical training and the behind-the-wheel training to successfully complete the course and to be eligible to receive a driving skills test.
4. Section C: Must document the completion of theoretical training.
5. Section D: Must document the completion of behind-the-wheel training.
6. Section E: If completed, you must include the "No Drive Test Required" stamp and signature of the instructor.
7. The applicant must submit the completed form at the time of application for a driver's license.
8. A form containing any irregularities, including, but not limited to, strike outs, erasures, or the use of white-out is invalid and will not be accepted by the BMV.
