Chris Lowery

Indiana Commissioner for Higher Education

Chris Lowery was appointed in 2022 to serve as Commissioner for Indiana's Commission for Higher Education, the coordinating agency charged with ensuring the state's postsecondary education system is aligned to meet the needs of students and the state. Prior to joining the Commission, Lowery was senior vice president, workforce, careers, and adult strategy at Ivy Tech Community College where he provided overall leadership of Ivy Tech workforce and career initiatives and organization. Before working in higher education, Lowery led public policy and engagement for Hillenbrand, Inc. and served as an aide to former Indiana Governor Robert D. Orr and then-Senator Dan Quayle.



As Commissioner, Lowery is committed to increasing postsecondary attainment, economic and social mobility and outcomes, and return on investment by increasing the college-going rate, engaging adult learners, improving completion rates, and retaining college graduates. He is focused on ensuring students of all ages understand the value proposition of higher education. He collaborates with policymakers, higher education leaders and community partners to maintain college affordability and guarantee quality higher education is delivered and tied to career relevance as the Commission continues its efforts to realize the state's goal of at least 60 percent of Hoosiers with quality education and training beyond high school.

Currently, Lowery serves on the Boards of the Richard M. Fairbanks Foundation, United Ways of Central Indiana and Executive Committee, Council for Adult and Experiential Learning (CAEL), and the Higher Education Working Group of the American Enterprise Institute. In addition, he serves on the Board and Executive Committee of the State Higher Education Executive Organization.

Lowery is a recipient of the Sagamore of the Wabash, the Distinguished Alumni Award of the Indiana University O'Neill School of Public Affairs, and the Distinguished Alumni Award of Indiana Wesleyan University. In addition, he was named to the "Indiana 250" most influential business leader by the Indianapolis Business Journal in 2023 and 2024. He is a regular speaker in Indiana and nationally on topics ranging from the future of higher education, the economy and workforce preparedness to innovation, leadership, and social impact investing. Lowery holds a Bachelor of Science in Public Affairs from Indiana University and a Master of Science in Management from Indiana Wesleyan University.

Justin Draeger

Keynote Speaker

As Strada's senior vice president, Affordability, Justin Draeger focuses on connecting individuals to opportunity by making postsecondary education more affordable and accessible.

He works to restore trust in higher education by improving price transparency, simplifying financial aid, and promoting efficiencies that lower costs. Draeger champions innovative cost-sharing models that close funding gaps for disadvantaged students, prioritizes need-based aid, and emphasizes fair measures of student and family need, ensuring every student can meaningfully contribute to their education.

Draeger joined Strada in 2024 after spending more than 14 years as president and chief executive officer of the National Association of Student Financial Aid Administrators. He served as a prominent advocate and voice for student financial aid issues and was the principal liaison among NASFAA members, the U.S. Congress, federal agencies, and the media.

Since 2002, Draeger has played pivotal roles in administering, interpreting, communicating, and shaping student financial aid policy. His experience includes positions as a director of financial aid, regulatory and policy analyst, and spokesperson, along with senior roles in government relations, communications, and policy development. He serves on several boards dedicated to advancing health and education.

Draeger earned his bachelor's degree from Brigham Young University and a Master of Business Administration in finance from Baker College.
