#### SECTION ONE GENERAL INFORMATION AND REQUESTED PRODUCTS/SERVICES

#### 1.1 INTRODUCTION

It is the intent of the Indiana Commission for Higher Education (Commission) in coordination with the Indiana Department of Education (IDOE) to solicit responses to this Request for Proposal (RFP) in accordance with the statement of work, proposal preparation section, and specifications contained in this document. This RFP is being posted to the Commission's website (<u>http://www.in.gov/che/3171.htm</u>). Neither this RFP nor any response (proposal) submitted hereto are to be construed as a legal offer.

### 1.3 PURPOSE OF THE RFP

The purpose of this RFP is to select a vendor that can satisfy the need for project management of processes and policies surrounding career scholarship accounts and high school redesign efforts and the legislative mandates of House Enrolled Act 1002-2023.

### 1.4 BACKGROUND

Indiana is well-positioned to lead the nation in redesigning the high school experience to ensure all students have the flexibility to access courses and experiences that ignite their purpose and set them up for success beyond high school. During Indiana's 2023 legislative session, lawmakers sought to leverage current collaborative efforts among state government, K-12 education, higher education, business/industry and other key partners to provide more opportunities to students via House Enrolled Act (HEA) 1002. To understand how Indiana arrived in this position, it's first helpful to understand the existing challenges and opportunities.

The State of Indiana, like other states, is grappling with the challenges of developing talent for the increasing and changing demands of a nimble workforce. Advances in technology and a rapidly evolving economy have led to historically low unemployment rates coupled with urgent questions about whether K-12 and postsecondary systems are truly preparing learners for the careers of today and tomorrow. Consider a few key data points related to both employer supply and demand, and the state of postsecondary attainment in Indiana:

- In March 2021, the nation's economy added 916,000 jobs, but only 7,000 of those jobs were for workers with only a high school diploma according to data from the United States Bureau of Labor Statistics.
- According to the Indiana Chamber of Commerce's 2022 employer survey, 62 percent of employers said that the supply of applicants did not meet demand, and 74 percent of employers stated that they left jobs open the past year due to under-qualified applicants.
- Meanwhile, Indiana's postsecondary going rate (college and pursuit of workforce certificates) has been steadily declining over the last several years and has fallen to 53 percent in 2021 according to data from the Commission.

These trends illustrate both the importance of pursuing and attaining employer-valued credentials – as well as the challenges that many Hoosiers will face if they are underqualified and unprepared for the demands of postsecondary educational opportunities and the workforce. If learners are to succeed in sustainable-wage occupations and the modern economy, they will need to attain a postsecondary credential of value. If employers and local/regional economies are to thrive, they will need a reliable supply of qualified talent. For these statements to be actualized, we must change the way we prepare Indiana's students for life beyond high school.

The services sought in this RFP are to support the Commission, IDOE, and TOS with its obligations under this project and this law, including the direct outreach, triage of responses and the reporting of data to the General Assembly.

# 1.5 SUMMARY SCOPE OF WORK

The Commission in partnership with the IDOE is requesting proposals from organizations to provide project management of the various initiatives outlined in HEA 1002; the coordination between relevant agencies to include the Governor's Workforce Cabinet (GWC), the Department of Workforce Development (DWD) and the Office of the Treasurer of the State (TOS); a statewide communication plan to all relevant stakeholder groups to be involved and impacted by high school redesign; and the development of a shared data plan to collect and evaluate success of the initiatives. If successful, this work will lead to the successful design and implementation of Indiana's new high school model to include an accountability system built on outcomes such as credentials of value and high-quality work-based learning connected to career pathways; and the design of outcomebased systems that both increase student opportunities and incentivizes student completion through a career scholarship program and credential completion grants.

#### 1.9 PRICING

Pricing on this RFP must be firm and remain open for a period of not less than 180 days from the proposal due date. Any attempt to manipulate the format of the document, attach caveats to pricing or submit pricing that deviates from the current format will put your proposal at risk. If the proposal is accepted, the pricing must remain firm during the term of the contract unless the scope of work required by the Commission and IDOE changes.

### 1.10 CONFIDENTIAL INFORMATION

Respondents are advised that materials contained in proposals are subject to the Access to Public Records Act (APRA), IC 5-14-3 *et seq.*, and, after the contract award, the entire RFP file may be viewed and copied by any member of the public, including news agencies and competitors. Respondents claiming a statutory exception

to the APRA must indicate so in the Cover Letter. Confidential Information must also be clearly marked. The Respondent must also specify which statutory exception of APRA that applies. The State reserves the right to make determinations of confidentiality. If the Respondent does not identify the statutory exception the Procurement Division will not consider the submission confidential. If the State does not agree that the information designated is confidential under one of the disclosure exceptions to APRA, it may seek the opinion of the Public Access Counselor. Prices are not confidential information.

# 1.12 TAXES

### 1.13 SECRETARY OF STATE REGISTRATION

### 1.15 COMPLIANCE CERTIFICATION

Responses to this RFP serve as a representation that it has no current or outstanding criminal, civil, or enforcement actions initiated by the State, and it agrees that it will immediately notify the State of any such actions. The Respondent also certifies that neither it nor its principals are presently in arrears in payment of its taxes, permit fees or other statutory, regulatory or judicially required payments to the State. The Respondent agrees that the State may confirm, at any time, that no such liabilities exist, and, if such liabilities are

discovered, that State may bar the Respondent from contracting with the State, cancel existing contracts, withhold payments to setoff such obligations, and withhold further payments or purchases until the entity is current in its payments on its liability to the State and has submitted proof such as payment to the State.

# 1.16 CONFLICT OF INTEREST

Any person, firm or entity that assisted with and/or participated in the preparation of this RFP document is prohibited from submitting a proposal to this specific RFP. For the purposes of this RFP "person" means a state officer, employee, special state appointee, or any individual or entity working with or advising the State or involved in the preparation of this RFP proposal. This prohibition would also apply to an entity who hires, within a one-year period prior to the publication of this RFP, a person that assisted with and/or participated in the preparation of this RFP.

# 1.17 EQUAL OPPORTUNITY COMMITMENT

Pursuant to IC 4-13-16.5 and in accordance with 25 IAC 5, Executive Order 13-04 and IC 5-22-14-3.5, it has been determined that there is a reasonable expectation of minority, woman, and Indiana veteran business enterprises subcontracting opportunities on a contract awarded under this RFP. Therefore, a contract goal for Minority Business Enterprises, Woman Business Enterprises, and Veteran Business Enterprises have been established and all respondents submitting a MWBE or IVOSB Subcontractor Commitment Form will be expected to comply with the regulation set forth in 25 IAC 5, Executive Order 13-04 and IC 22-14-3.5.

#### 2.2 COVER LETTER

The Cover Letter must address the following topics.

2.2.1 Agreement with Requirement listed in Section 1

The Respondent must explicitly acknowledge understanding of the general information presented in Section 1 and agreement with any requirements/conditions listed in Section 1.

2.2.2 Summary of Ability and Desire to Supply the Required Products or Services

The Cover Letter must briefly summarize the Respondent's ability to supply the requested products and/or services that meet the requirements defined in Section 2.4 of this RFP. The letter must also contain a statement indicating the Respondent's willingness to provide the requested products and/or services subject to the terms and conditions set forth in the RFP including, but not limited to, the State's mandatory contract clauses.

2.2.3 Signature of Authorized Representative

A person authorized to commit the Respondent to its representations and who can certify that the information offered in the proposal meets all general conditions including the information requested in Section 2.3.2, must sign the Cover Letter. In the Cover Letter, please indicate the principal contact for the proposal along with an address, telephone and fax number as well as an e-mail address, if that contact is different than the individual authorized for signature.

#### 2.2.4 Respondent Notification

Invoices must detail expenses and charges in accordance with any purchase orders issued; total payment shall not exceed the accepted bid amount. #### 2.3.4 Subcontractors

The Respondent is responsible for the performance of any obligations that may result from this RFP and shall not be relieved by the non-performance of any subcontractor. Any Respondent's proposal must identify all subcontractors and describe the contractual relationship between the Respondent and each subcontractor. Either a copy of the executed subcontract or a letter of agreement over the official signature of the firms involved must accompany each proposal.

Any subcontracts entered by the Respondent must be in compliance with all State statutes and will be subject to the provisions thereof. For each portion of the proposed products or services to be provided by a subcontractor, the Business Proposal must include the identification of the functions to be provided by the subcontractor and the subcontractor's related qualifications and experience.
