# **Minutes of Meeting**

## **CHAIR'S REPORT**

Hello everyone. I know today has turned out to be a very busy one for many of us, with several overlapping board commitments. We'd like to begin with something that is bittersweet—but also a moment of celebration—as this marks Commissioner Lowery's last official Commission Meeting.

I just want to say it's been an absolute honor and pleasure to work with Chris over the years—not only in his role as Commissioner, but even before that. Chris has been a deeply dedicated servant leader throughout his career, and especially here at the Commission, where he has led the team with grace and strength. His vision and organizational leadership have made a tremendous impact on higher education and, more broadly, on the state of Indiana.

You have my— and I know, our—utmost respect and gratitude for everything you've done for Indiana, for our Commission, for our higher education partners, and most importantly, for the students of Indiana. We've truly been blessed to have you. And while this is your last official meeting, we know you're not going far. You'll continue to be involved in conversations and initiatives moving forward, and we're grateful for that.

With that, I'd like to turn it over to my friend Dennis Bland to read a resolution in honor of Chris.

WHEREAS, Commissioner Chris Lowery has served the State of Indiana as Commissioner for Higher Education for more than three years and has devoted much of his life to increasing economic and social mobility and prosperity for all students through his previous leadership at Ivy Tech Community College and his long-tenured service on the board of the Batesville Community School Corporation; and

WHEREAS, Commissioner Lowery led the development of the Commission's HOPE (Hoosier Opportunities & Possibilities through Education) Agenda which serves as the agency's strategic plan through 2030 and challenges Indiana to become a top 10 state in the nation in seven key measures centered on addressing enrollment, completion, and graduate retention; and

**WHEREAS,** Commissioner Lowery brought clarity to the Commission's strategy and actions by developing the agency's first strategic management process, challenging every staff member to set audacious goals aligned to the agency's HOPE Agenda; and

**WHEREAS,** under his leadership, Indiana enacted the most comprehensive overhaul of its Outcomes-Based Performance Funding formula, expanding beyond completion metrics to include new measures for enrollment, graduate retention, and research impact; and

**WHEREAS,** the comprehensive overhaul of Indiana's funding formula has already yielded measurable success, including reversing a decade-long decline in college enrollment with two consecutive years of growth, and elevating the state's college completion rate from 14th to 9th in the nation; and

**WHEREAS**, Commissioner Lowery worked alongside statewide partners to champion the automatic enrollment of eligible students into the 21st Century Scholars program, increasing participation from fewer than 20,000 to nearly 50,000 students enrolled annually; and

**WHEREAS**, he has been a tireless advocate for college affordability, successfully increasing the maximum Frank O'Bannon Grant award and significantly improving Indiana's FAFSA filing rate—reaching the state's goal of 60% of high school seniors filing in 2025; and

**WHEREAS**, recognizing the importance of early college credit, Commissioner Lowery led the rapid expansion of the Indiana College Core, growing the number of high schools offering the certificate from 84 in 2022 to 312 in 2025; and

**WHEREAS**, Commissioner Lowery led a significant shift in the Commission's data strategy moving from relying on lagging data for analysis to utilizing relevant data as a source of leading indicators to evaluate strategic performance of policies and programs; and

**WHEREAS,** Commissioner Lowery enhanced statewide awareness of Indiana's world-class higher education opportunities through the *Indiana Pre-Admissions* and Enrollment Ready initiatives, which annually provide more than 300,000 high school students and their families with critical information to support informed college choices; and

**NOW THEREFORE BE IT RESOLVED,** that the Commission for Higher Education expresses its deep appreciation for Commissioner Chris Lowery as he concludes his distinguished career in public service, and wishes him well as he finds new ways to serve his family, Hoosier students, and the state in this next chapter.

## **Data Updates**

# **Data Strategy**

- 1. In 2023, the Commission shifted to a business intelligence team, an intentional pivot to how it values data and creates value from its data.
  - i. Research- and data-informed challenges and solutions
  - ii. Leading indicators rather than lagging data
  - iii. Promote collaboration
    - 1. To prevent duplicative efforts and invite partnerships Partnership Pentagon

#### **Enrollment**

- 1. After a decade of decline, enrollment has increased by 2% each year for the past two years.
- 2. Over 187,000 Hoosier students have been automatically enrolled in 21st Century Scholars across four cohorts.
- 3. Over 198,000 Pre-Admissions letters have been mailed to high school seniors across three cohorts.
- 4. 60% of high school seniors filed the FAFSA this year.
- 5. The number of high schools offering the Indiana College Core increased from 84 in 2021 to 312 in 2025.
  - An additional \$250 million in need-based financial aid will be awarded to Hoosiers through 2030 (Frank O'Bannon).

# Completion

- 1. Completion rates have increased from 14th in the nation to 9th in the nation.
- 2. Senate Enrolled Act 8-2024 supported reverse transfer and three-year degrees to support completion rates.
- Senate Enrolled Act 448-2025 supported the Commission's push for robust degree program review. In July, 404 programs were eliminated, suspended, or merged/consolidated.

#### **Graduate Retention**

- 1. Indiana gained an R1 research institution in 2025, bringing the total of R1 Indiana institutions to four.
- 2. Indiana institutions were 14th in the nation at attracting students in 2022, that has risen to 8th in the nation.

3. Indiana is the first and only state to include graduate retention in outcomes-based performance funding metrics.

## **Initiative Updates**

# The Need for Higher Education

- 1. According to Georgetown's Projections of Jobs, Education, and Training Requirements through 2031 State Report:
  - Of Indiana's 378,000 job openings that will be created or available from 2021-2031, 236,000 of those jobs will require education and training beyond high school.
- 2. Nationally, by 2031, 66% of "good jobs" will be distributed to those on a bachelor's degree pathway.
  - i. Only 19% will be distributed to a middle-skills pathway and 15% to high school pathways.

## The Future of Higher Education in Indiana

- 1. More collaboration with employers to strengthen the education to workforce pipeline.
- 2. Market alignment to better serve students and provide the best resources and programs at an affordable cost.
- 3. Embrace technology to set our institutions apart and to be globally competitive.

## Partnership Weaves the Fabric of Civil Society

- 1. The CHE team has embraced changes and challenges.
- 2. Set stretch goals with high expectations that were met with high output.
- 3. Working with those within the agency, other agency partners, and external partners.
- 4. Thanks to the partners who have joined and led this work.
- 5. As we blur the lines of education, we blur the lines in working together towards a common goal.
