CHAIR'S REPORT

COMMISSIONER'S REPORT

Commissioner Lowery thanked Chairman Dan Peterson, the Senate staff, and President Pro Tempore Bray for hosting the meeting.

Data Updates

Indiana's Big Goal

- 1. Sixty percent of Hoosiers will have a degree or credential beyond high school by 2025.
 - In 2022, 42 percent of Hoosiers held a two- or four- year degree or higher education, and 53 percent of Hoosiers held a certificate, two- or four- year degree, or higher.

Attainment Ranking

- 1. In 1960, Indiana ranked 39th in bachelor's degree attainment, and 2022 data shows Indiana is 40th in bachelor's degree attainment.
 - i. 39th in attainment of adults within associate degree or higher.
 - ii. 5th in sub-associate degree attainment.
 - iii. 28th in total education attainment beyond a high school diploma.

Talent Pipeline

- 1. Indiana ranks 40th nationally in graduate retention.
 - i. The high school to college going rate is 53 percent, a steep decline of 15 percent between 2012 and 2022.
 - ii. Indiana has moved from 20th to 11th nationally in overall college graduation with a rate of 68 percent.

Leading and Forecasting

- 1. Two-year-old data can be a good gauge, but not to base real-time efforts and strategy.
 - i. College-going rate.
- 2. Up-to-date data that can be used to gauge effectiveness of current programs and policies.
 - i. Enrollment rates, CTE, CSAs, FAFSA, completion rates.
- 3. Policies and programs as strategic initiatives to actively address current data trends.
 - i. Strategic initiatives such as Pre-Admissions, 21st Century Scholars Automatic Enrollment, College Success Coaches, Career Navigation.

Vision Alignment

 - i. Students in Indiana are responsible for the 5th highest share of their education costs in the nation.

CHAIR'S REPORT

Data Updates

Indiana's Big Goal

Funding Picture

- 1. In 2023, Indiana ranked 43rd in Public Higher Education Appropriations per full time equivalency (FTE) by State.

- 2. Ranked 6th in the nation for holding down tuition for the last decade.
- 3. New state revenue is expected to be modest.

BackgroundBeginning in 2024, the Commission updated the traditional cycle

of annual reports, combining elements of all previous reports (College Readiness, Completion, etc.) into one *State of Higher*

Education in Indiana Report.

This report follows the structure of the HOPE (Hoosier Opportunities and Possibilities through Education) Agenda, which serves as the agency's strategic plan through 2030. Each of the seven goals of the HOPE Agenda are supported with current national rankings and programming initiatives the Commission is administering to support the corresponding goal. This shift in reporting style was designed to promote transparency in progress and democratization of data. Moving forward, the Commission will release the annual *State of Higher Education in Indiana Report*

each fall.

The 2024 State of Higher Education in Indiana Report will be published on the day of the Commission meeting (November 14) in tandem with the Commission's HOPE Agenda Dashboard, an interactive data dashboard that will update quarterly on these

tracked goals.

Bloomington

Staff Recommendation That the Commission for Higher Education approve the Bachelor

of Science in Public Health in Sexual and Reproductive Health offered by Indiana University Bloomington in accordance with the background discussion in this agenda item and the Program

Description.

Background Review Process. The Academic Affairs and Quality Committee

discussed this program at its October 7, 2024 meeting and

indicated a need for full discussion.

Similar Programs in Indiana. In the independent or private non-

profit sector, there are no similar programs offered.

In the *proprietary* or private for-profit sector, there are no

similar programs offered.

Within the *public* sector, there are no similar programs offered.

Related Programs at Indiana University. IU Bloomington currently offers four specialized degrees within the Bachelor of Science in Public Health: Epidemiology, Fitness and Wellness,

Environmental Health, and Community Health. The proposed

degree would be the fifth.

<u>Program Focus.</u> The program's curriculum utilizes pre-existing coursework and requires no additional facilities, capital investment or faculty members. In addition to general education, the curriculum includes the 83-90 credit hours major specific coursework. This includes 3-10 credits in Anatomy and Physiology, the 15 credit Public Health Core, 32 credits in Sexual and Reproductive Health, 12 additional required public health credits not included in the Public Health Core, and 21 credit hours of elective Public Health Courses. Graduates are expected to complete an internship for this degree and the proposed program will prepare students to pursue a Master of Public Health Degree.

Graduates of the program will be prepared for careers as Health Education Specialists, Community Health Workers, and Postsecondary Educators. These professions are all growing faster than the average 2020-2030 job growth rate. Further, Heath Education Specialists, the main occupation identified by this program, is projected to grow 11% in Indiana by 2031 with roughly 200 annual openings needing to be filled.

CHE 24-23 Master of Science in Education in Evidence-Based Practices in Educational Psychology to be offered by Indiana University Bloomington

Proposal received on September 13, 2024

Fifth Year Projected Enrollment: Headcount – 46, FTE – 33

Fifth Year Projected Degrees Conferred: 30

The proposed Master of Science in Education in Evidence-Based Practices in Educational Psychology will be offered in person by Indiana University Bloomington online through the School of Education within the Department of Counseling and Educational Psychology.

The curriculum of the proposed M.S. in Education in Evidence-Based Practices in Educational Psychology utilizes current faculty members and coursework and requires no additional facilities or capital investment. However, two new courses will be developed for this program by the current faculty: an introductory course and a capstone course. The students will be required to complete eight core courses (21 credits) and three additional courses (9 credits) from a variety of courses in each of the three areas: Human Development, Inquiry or Improvement Science, and Curriculum and Instruction.

This program leverages IU's existing strengths in the education field and will serve as a way for current educational professionals to be further equipped to improve their knowledge of learning, motivation, and implementation of evidence-based practices in educational psychology.

The proposed Master of Science in Education in Evidence-Based Practices in Educational Psychology requires 30 credit hours to complete.

CHE 24-24 Master of Public Policy to be offered by Indiana University Bloomington

Proposal received on September 13, 2024

Fifth Year Projected Enrollment: Headcount – 65, FTE – 57

Fifth Year Projected Degrees Conferred: 40

The proposed Master of Public Policy will be offered in person and online by Indiana University Bloomington through the O'Neill School of Public and Environmental Affairs.

The curriculum of the proposed Master of Public Policy utilizes current faculty members and coursework from O'Neill and requires no additional facilities or capital investment. Indiana University Bloomington currently offers a Master of Public Affairs through the O'Neill School of Public and Environmental Affairs, which enrolled 337 students and had 200 graduates in 2023.

There are currently no Master of Public Policy (MPP) degrees at public institutions in Indiana. The proposed degree will be the first offered on an IU campus and in the state of Indiana. The O'Neill School's Master of Public Affairs (MPA) program would complement and strengthen the Master of Public Policy (MPP) degree. With the consecutive #1 rankings for the MPA program, O'Neill is well-known for public affairs and public policy programs, which would attract new prospective students to the MPP degree. This program is unique in that it allows for a variety of concentrations, allowing for students to tailor their learning experiences to their career interests.

The proposed Master of Public Policy requires 48 credit hours to complete. Students will be required to take 24 credits from the MPP core, 6 credits in management, 6 credits in advanced tools, such as statistics for research, 9 credits in a concentration: health policy, environmental policy, energy and climate policy, social policy, equity and social justice, or public finance, and either a 3-credit internship or elective course.

CHE 24-25 Master of Design Leadership to be offered by Indiana University Bloomington

Proposal received on September 13, 2024

Fifth Year Projected Enrollment (Aggregate): Headcount – 17, FTE – 15 Fifth Year Projected Degrees Conferred (Aggregate): 10

The proposed Master of Design Leadership will be offered by Indiana University Bloomington through the Eskenazi School of Art, Architecture and Design.

The coursework for the proposed program will be taught by existing faculty within the Eskenazi School. The new courses will require backfilling seven existing courses taught by faculty, which will likely be filled by adjunct faculty members. The proposed program will have a limited impact on currently existing facilities, utilizing spaces and resources that exist within the Eskenazi School, such as the Maker and Design Labs.

The Master of Design Leadership prepares students to be effective leaders in the field of design working with diverse communities, stakeholders, and clients to solve the dynamic and complex problems faced by contemporary society. This program requires two Project Studio courses that will be tailored to students' interests and allow them to find solutions to individualized design problems.

There are currently no other programs in the state that are similar in nature to the proposed program.

The proposed Master of Design Leadership requires 30 credit hours to complete. Students will complete 9 credits in the Design Core, 9 credits of interdisciplinary seminars and/or studios, and 12 credits of Design Problem Solving.

CHE 24-26 Ph.D. in Information Science to be offered by Indiana University Indianapolis

Fifth Year Projected Enrollment (Aggregate): Headcount – 15, FTE – 15 Fifth Year Projected Degrees Conferred (Aggregate): 3

The proposed Ph.D. in Information Science will be offered by Indiana University Indianapolis through the Department of Library and Information Science within the Luddy School of Informatics, Computing, and Engineering.

The proposed Ph.D. in Information Science utilizes current faculty members from the Department of Library and Information Science, Human-Centered Computing, and BioHealth Informatics departments. The program requires no additional facilities or capital investments.

This program equips students with the essential knowledge and skills to excel in various educational and professional roles across diverse sectors, including higher education, research libraries, archives, government agencies, consulting firms, and nonprofit organizations. This program is unique to others in that its students will participate in community-engaged scholarship. The Luddy School has robust program offerings, including a Master of Library and Information Science, which had 106 graduates in 2023, and this program would add to the robustness of the department.

The proposed Ph.D. in Information Science requires 90 credit hours to complete. The curriculum includes an information science core, research and methods courses, electives or minors that can be tailored to the students' interests, and a dissertation.

BUSINESS ITEM A: 2025-2026 Frank O'Bannon Grant Schedule of Awards

Staff Recommendation Adopt the amounts included in the attached 2024-2025 Frank

O'Bannon Grant Schedule of Awards.

Background

IC 21-12-1.7-3(a) requires the Commission to annually adopt a schedule of award amounts for the Higher Education Award (HEA) and Freedom of Choice grant (FOC) – together known as the Frank O'Bannon Grant. The schedule must provide award amounts on the basis of the student's financial need and the type of institution the student is attending. Per IC 21-12-1.7-3(c), when renewing HEA or FOC, a student earning at least 30 credit hours or the equivalent in the year the student last used aid must receive a larger award. This larger award is referred to as the "On-Time" amount. First-time recipients are initially eligible for the larger award. Students earning less than 30 credit hours, but more than 24 credit hours are eligible for a

Time" amount.

For the 2024-2025 award cycle, the federal government significantly changed the need analysis used to determine eligibility via the Free Application for Federal Student Aid (FAFSA). Further, states and institutions received FAFSA information nearly five months later than normal and the initial information had significant inaccuracies. Due to this delay, the Commission elected to maintain 2023-2024 award amounts for the 2024-2025 award cycle, understanding there would need to be significant updates for the 2025-2026 awards. This proposal recalibrates the O'Bannon awards to be in line with the new federal need analysis.

Indiana's 21st Century Scholars Program doubles in size following automatic enrollment law

A record number of Hoosier students have joined Indiana's 21st Century Scholars program, more than doubling enrollment for the 2027 and 2028 cohorts, the Indiana Commission for Higher Education announced Thursday.

More than 90,000 students have joined the program — a statewide grant program that funds lower income student attendance at two- and four-year schools — after <u>a 2023 law</u> allowed qualifying students to be automatically enrolled.

"This legislative change has allowed us to realize the ideals of the 21st Century Scholars Program even more fully — the promise that if your family is low income but you work hard at school, you can attain a debt-free college education and secure a better life for yourself and your family," said Rep. Earl Harris, D-East Chicago, who authored the automatic enrollment legislation.

In the 2028 cohort, more than 50,000 students were initially enrolled, according to CHE. Nearly 46,000 students have additionally enrolled in the 2027 cohort.

State officials said enrollment ranged from 16,000 to 19,000 students per cohort in years prior.

The <u>scholarship fund</u>, created in 1990, covers full tuition and fees at Indiana colleges and universities for low-income students, who enroll in the 8th grade. Lawmakers will have to fund the scholarships in future budgets.

Students who are income-eligible for the National School Lunch Program are automatically enrolled in 21st Century Scholars. They must still meet subsequent requirements but can opt out at any time.

Scholars had an 81% graduation rate in 2021, compared to 30% of their non-scholar, low-income peers, CHE noted. More than 50,000 collegiate degrees have been earned by recipients since the program's inception.

"As the 2027 and 2028 program cohorts move toward high school graduation and college enrollment, I can't wait to see what these students do in their careers and in our state," Harris' statement continued. "The success of 21st Century Scholars shows us that closing the achievement gap for low-income and minority students is possible if the state and state legislature are willing to get it done. I look forward to working on more bipartisan, commonsense education solutions for our state."

Indiana colleges see higher enrollment this fall, though long-term declines not fully reversed

Indiana's full-time college enrollment increased this fall, marking the highest one-year increase since fall 2010.

According to a report from the state Commission for Higher Education, Indiana public college enrollment increased by 2 percent over fall 2023. It's the second straight year with an increase after 12 years of decline.

More than 206,000 students enrolled full-time in Indiana public colleges.

"We are hopeful this is an indication that the declining trends will continue to reverse," said Chris Lowery, Indiana Commissioner for Higher Education. "As much work remains, I remain pleased but not satisfied on this update."

Lowry credits the commission's initiatives for the increase. Those include a pre-admissions program and expanded financial aid.

Indiana State University has the largest drop in enrollment, decreasing about 32 percent in the past five years. Purdue University's flagship campus in West Lafayette had the most growth during that time with a 26.5 percent increase. Enrollment at IU Bloomington has grown about 15 percent over the last five years.

Enrollment at two-year colleges — Ivy Tech Community College and Vincennes University — has decreased over the last five years. Rates for Ivy Tech show a 9 percent decrease, and Vincennes saw about a 29 percent decrease.

Holcomb adviser leaving for Higher Education Commission position

Matthew Butler is leaving his job as a top adviser to Gov. Eric Holcomb for a leadership position at the Indiana Commission for Higher Education.

Butler has been Holcomb's senior policy adviser for education and workforce since 2021. He joins several other <u>Holcomb administration officials departing for new jobs</u> ahead of Holcomb's second term as governor ending in January.

Butler will become the Higher Education Commission's senior associate commissioner and chief academic officer beginning Nov. 11, the commission announced this week.

Before joining the governor's staff, Butler was the vice president of external engagement at INvestEd and both a fiscal analyst and a policy adviser with the Indiana House Republicans. Commissioner for Higher Education Chris Lowery said Butler "brings an incredible amount of legislative and policy experience to the commission."

"As the Commission's chief academic officer, he will take on the important task of approving new and reviewing existing degrees, increasing transfer options, and ensuring academic offerings have workforce relevance," Lowry said in a statement. "With his extensive background, I am excited to see him take on these challenges."

Butler will lead the commission's process for approving and reviewing the more than 3,000 degree offerings among Indiana's public colleges and universities. Butler will also serve as the liaison between the commission and academic institutions from around the state and as the executive director of the Board for Proprietary Education.
