SEA 448 2025 Report

Pursuant to IC 21-40-6-1, no later than November 1, 2025 and each November 1 thereafter, the Commission must make a report available to the legislative counsel and on the Commission's website containing student enrollment information at each state educational institution and in each state educational institution's programs of engineering and computer science disaggregated by: those who are Indiana residents and not Indiana residents; those who are United States citizens and not United States citizens; for those not United States citizens, by student's country of origin; and the total number of students enrolled in dual credit or dual enrollment at the institution.

Definitions

Enrolled is defined as a non-high school student registered for courses in a degree-seeking program offered at the institution.*

Headcount is defined as the distinct, unduplicated headcount of enrolled students.

Indiana residents are defined as enrolled students paying resident tuition rates as reported by the institution.

Non-Indiana residents are defined as enrolled students paying non-resident or reciprocity tuition rates as reported by the institution.

Non-United States citizens are defined as enrolled students who are neither native-born or nor naturalized citizens of the United States, including Resident Aliens, Non-Resident Aliens, and students with an unknown, undeclared, or not applicable U.S. citizenship status.

Country of origin is defined as the student's country of origin at the time of admission to the institution (not necessarily where the student currently resides, where the student was born, or the student's country of citizenship. If country of origin is unknown, the institution may report as 'unknown'.

Engineering is defined as a program classified in the two-digit Classification of Instructional Programs (CIP) series '14 - Engineering' or series '15 - Engineering Technologies / Technicians'.

Computer Science is defined as a program classified in the two-digit Classification of Instructional Programs (CIP) series '11 - Computer and Information Sciences and Support Services' or a program classified in one of the following four-digit CIP series considered 'Computer Science, Other': '26.11 - Biomathematics, Bioinformatics, and Computational Biology'; '27.03 - Applied Mathematics'; '30.08 - Mathematics and Computer Science'; '30.16 - Accounting and Computer Science'; '30.30 - Computational Science'; '30.48 - Linguistics and Computer Science'; '30.70 - Data Science'; or '30.71 - Data Analytics'.

* exception: dual credit/dual enrollment metric

Data Notes

2025 report data is from Fiscal Year 2024 (July 1, 2023 - June 30, 2024)

Enrollment headcounts are derived values from the term-level information reported by institutions, deduplicating students that enrolled multiple semesters at a single institution. Deduplication is implemented by taking semester in which the student was enrolled at the highest degree in a given fiscal year. Students may count towards enrollment in more than one program.
