I. Call to Order

Devon McDonald called the meeting to order at 11:04 a.m. A quorum was recognized.

II. Approval of September 6, 2024, Board Meeting Minutes

Amy Karozos made a motion to approve the September 6, 2024, Board Meeting minutes. Chief Kyle Prewitt seconded the motion. The motion passed by consent.

III. Executive Director's Report

Devon McDonald gave a brief update of his report.

Division Updates:

- <u>Behavioral Health</u>: The division continues to work on data, outreach, and education with the local coordinating councils. The division is also working on a year end report and updated survey in conjunction with the Research division.
- <u>Youth</u>: The division has been focused heavily on outreach and staff training. They just closed another round of solicitations and will be working on scoring them and presenting them to the YJOC.
- <u>Drug and Crime Control</u>: The division has focused primarily on grant closeouts and the JAG RFP and scoring.
- Research: The division in coordination with JRAC wrote the annual report to evaluate criminal code reform. They also authored the report Juveniles Under Adult Court Jurisdiction submitted to the legislative council on October 30th. They also completed and submitted the 2024 Youth Grants Report.
- <u>Traffic Safety</u>: The state has seen a decrease in traffic fatalities compared to last year at this time. The division hosted the GHSA conference this year. There were over 800 attendees, and it was the largest or second largest conference in GHSA history. They hosted the first Traffic Safety Day at the Indianapolis Motor Speedway. Indiana's seatbelt usage rate is 93.6% for 2024, which is an increase from 2023.
- <u>Victim Compensation</u>: The division has been busy processing applications and working on pending payments. As of December 4, 2024, the division has approved and is pending payment on \$2,766,445.06.
- <u>Victim Services</u>: The division has been focused heavily on grant execution and closeout as well as the SASP solicitation. To date, 71 subgrantee compliance visits have been completed in 2024.
- <u>Communications</u>: The division remains busy updating the ICJI website and working with the Traffic Safety Division on their public outreach and events.

• <u>Compliance Monitoring</u>: The division has been busy conducting both on-site and offsite compliance monitoring reviews and continues to provide technical assistance to subgrantees. Since the September meeting, ICJI has been repaid a total of \$6,208.83 due to the Team's monitoring activities.

Justin Forkner seconded the motion. Lori Torres asked a clarifying question which Natalie Huffman answered. The motion passed with 11 votes in favor and 0 votes against.

v. Lester L. Riggins

Judge AmyMarie Travis presented the subcommittee's recommendation to deny Mr. Riggins' application. Judge AmyMarie Travis made a motion to approve the recommendation. Judge Darrin Dolehanty seconded the motion. The motion passed with 11 votes in favor and 0 votes against.

Natalie Huffman gave a brief update on the Exoneration Fund following the first five years since its inception. Mark Stuaan and Lori Torres asked several clarifying questions, which Natalie Huffman answered. Bernice Corley expressed her appreciation for ICJI's handling of the Fund.

Natalie Huffman gave a brief update on House Bill 1003 and its impact on appeals of Victim Compensation claims.
