## APPROVAL OF MINUTES

State Comptroller Elise Nieshalla moved to approve meeting minutes. State Treasurer Daniel Elliott seconded, and the minutes were unanimously approved.

### TRANSFER TO THE DEPARTMENT OF TRANSPORTATION

The Indiana Department of Natural Resources (DNR) requests a transfer of \$28,000 from the Institutional Road Construction fund (30517) to the Indiana Department of Transportation (INDOT) County Match fund (30588). The agencies have entered into a MOU that will facilitate the environmental and historical analysis of the Camp Atterbury bridge project. State Treasurer Daniel Elliott moved to approve the transfer, State Comptroller Elise Nieshalla seconded, and the transfer was unanimously approved.

# TRANSFER TO THE DEPARTMENT OF TRANSPORTATION

The Indiana Department of Natural Resources (DNR) requests a transfer of \$1,250,000 from Institutional Road Construction fund (30517) to the Department of Transportation (INDOT) County Match fund (30588). The agencies have entered into a MOU that will facilitate the construction of a new bridge and rehabilitation of an existing bridge at Dunes State Park. State Comptroller Elise Nieshalla moved to approve the transfer, State Treasurer Daniel Elliott seconded, and the transfer was unanimously approved.

### TRANSFER TO THE FAMILY AND SOCIAL SERVICES ANDMINISTRATION

The Indiana Department of Health requests a transfer of \$3,746,837.50 from the Maternal and Child Health fund (30468) to the Family and Social Services Administration's (FSSA) Office of Medicaid Policy and Planning fund (13366). This reverses the Board of Finance transfer done in
