**APPROVAL OF MINUTES**

Approval of the minutes from the February 17, 2026, meeting.  
*Deputy Treasurer Kim Logan moved to approve meeting minutes, Deputy Comptroller Steve Daniels seconded, and the minutes were unanimously approved.*

**TRANSFER TO THE FAMILY AND SOCIAL SERVICES ADMINISTRATION**

The Department of Education requests a transfer of \$4,745,425 from the Tuition Support Fund (14930) to Family and Social Services Administration's (FSSA) Office of Medicaid Policy (OMPP) Medicaid Assistance Fund (15050) to pay the state share of school-based Medicaid payments. This transfer represents actual Medicaid payments made January 2026 through March 2026. *Deputy Treasurer Kim Logan moved to approve the transfer. Deputy Comptroller Steve Daniels seconded, and the transfer was unanimously approved.*

**TRANSFER TO THE FAMILY AND SOCIAL SERVICES ADMINISTRATION**

The Department of Corrections (DOC) requests a transfer of \$ 1,110,102.65 from DOC's Correctional Services Fund (13151) to the Family and Social Services Administration's (FSSA) Office of Medicaid Policy (OMPP) Medicaid Assistance Fund (15050) to pay the state share of Medicaid for individuals residing in a DOC facility. This transfer represents payments from October 2025 through December 2025. *Deputy Treasurer Kim Logan moved to approve the transfer. Deputy Comptroller Steve Daniels seconded, and the transfer was unanimously approved.*

**TRANSFER TO THE DEPARTMENT OF REVENUE**

The Department of Child Services (DCS) requests the transfer of \$274,510 from the Child Welfare Program Fund to the (12771) Department of Revenue's (DOR) Collection and Administration fund (10850). This transfer provides the required state match to support the administration of child support payment processing. Under the existing MOU between the two agencies, DCS will provide funding to DOR to manage the collection and processing of paper child support payments and related correspondence. *Deputy Treasurer Kim Logan moved to approve the transfer. Deputy Comptroller Steve Daniels seconded, and the transfer was unanimously approved.*




