State Budget Director Chad Ranney called the meeting to order at 9:00 a.m.

APPROVAL OF MINUTES

Approval of the minutes from the July 15, 2025, meeting.

Deputy Treasurer Kimberly Logan moved to approve meeting minutes. State Budget Director Chad Ranney seconded, and the minutes were unanimously approved.

TRANSFER TO THE DEPARTMENT OF EDUCATION

The Family and Social Services Administration's (FSSA) Office of Early Childhood and Out of School Learning (OECOSL) requests a transfer of \$1,156,707.51 from the Early Education Grant Pilot Program Fund (15980) to the Department of Education's (DOE) Operating Fund (15460). Pursuant to an MOU between the two agencies, DOE will utilize these funds as state match to improve early childhood education systems and enhance the quality of programs to support children's transitions to kindergarten.

Deputy Treasurer Kimberly Logan moved to approve the transfer, State Budget Director Chad Ranney seconded, and the transfer was unanimously approved.

TRANSFER TO THE CRIMINAL JUSTICE INSTITUTE

The Governor's Office requests a transfer of \$4,200,000.00 from Substance Abuse Prevention, Treatment and Enforcement Fund (57876) to the Criminal Justice Institute's (CJI) Substance Abuse Prevention, Treatment and Enforcement Fund (57871). Pursuant to an MOU between the agencies, CJI will utilize these funds to coordinate the state's efforts on substance abuse prevention, treatment, and enforcement, providing planning, and collaboration across state agencies and the local level.

Deputy Treasurer Kimberly Logan moved to approve the transfer, State Budget Director Chad Ranney seconded, and the transfer was unanimously approved.

TRANSFER TO THE DEPARTMENT OF HEALTH

The Governor's Office requests a transfer of \$800,000.00 from Substance Abuse Prevention, Treatment and Enforcement Fund (57876) to the Department of Health's (IDOH) Opioid Overdose Intervention Fund (57878). Pursuant to an MOU between the agencies, IDOH will utilize these funds for toxicology testing in suspected overdose-related deaths.

Deputy Treasurer Kimberly Logan moved to approve the transfer, State Budget Director Chad Ranney seconded, and the transfer was unanimously approved.




