CALL TO ORDER

Budget Director Chad Raney called the meeting to order at 9:00 a.m.

APPROVAL OF MINUTES

Approval of the minutes from the March 17, 2026, meeting.

Deputy Treasurer Kimberly Logan moved to approve meeting minutes, Deputy Comptroller Staci Schneider seconded, and the minutes were unanimously approved.

TRANSFER TO THE FAMILY AND SOCIAL SERVICES ADMINISTRATION

The Department of Education (DOE) requests to transfer \$931,677.52 from the DOE Operating Fund (15460) and \$598,113.84 from the Early Childhood Learning Fund (12341) to the Family and Social Services Administration's (FSSA) Early Education Grant Pilot Program Fund (15980). This transfer reflects the return of unused Preschool Development Grant (PDG) program state match to FSSA, as required by a Memorandum of Understanding (MOU) between the agencies. *Deputy Treasurer Kimberly Logan moved to approve, Deputy Comptroller Staci Schneider seconded, and the motion was unanimously approved.*

TRANSFER TO THE FAMILY AND SOCIAL SERVICES ADMINISTRATION

The Department of Corrections (DOC) requests a transfer of \$1,019,263.61 from the Correctional Services Fund (13151) to the Family and Social Services Administration's (FSSA) Office of Medicaid Policy (OMPP) Medicaid Assistance Fund (15050) to pay the state share of Medicaid for individuals residing in a DOC facility. This transfer represents payments from January 2026 through March 2026. *Deputy Treasurer Kimberly Logan moved to approve, Deputy Comptroller Staci Schneider seconded, and the motion was unanimously approved.*

TRANSFER TO THE DEPARTMENT OF NATURAL RESOURCES

The Indiana Destination Development Commission (IDDC) requests to transfer \$82,500 from the IDDC Operating Fund (11740) to Department of Natural Resources' (DNR) Outdoor Indiana Sales Fund (48640). Pursuant to a Memorandum of Understanding (MOU) between the two agencies, DNR will use these funds to support marketing efforts with the Indiana DNR Rewards Program. *Deputy Treasurer Kimberly Logan moved to approve, Deputy Comptroller Staci Schneider seconded, and the motion was unanimously approved.*

TRANSFER TO THE INDIANA DEPARTMENT OF CORRECTION

The Indiana Criminal Justice Institute (ICJI) requests to transfer \$381,833 from the Victim and Witness Assistance Fund (31310) to the Indiana Department of Correction's (IDOC) Victim & Witness Assistance Fund (31320). Pursuant to a Memorandum of Understanding (MOU) between the two agencies, these funds will be used to support the ongoing operations of the Statewide Automated Victim Information Notification System (SAVIN) and the Indiana Sex and Violent Offender Registry. *Deputy Treasurer Kimberly Logan moved to approve, Deputy Comptroller Staci Schneider seconded, and the motion was unanimously approved.*

TRANSFER TO THE INDIANA STATE POLICE

The Indiana Criminal Justice Institute (ICJI) requests to transfer \$3,175,000 from Substance Abuse Prevention Treatment Enforcement Fund (57871) to the Indiana State Police's (ISP) Opioid Settlement Fund (57872). Pursuant to a Memorandum of Understanding (MOU) between the two agencies, ISP will use these funds to support drug enforcement operations aimed at combating the drug epidemic. *Deputy Treasurer Kimberly Logan moved to approve, Deputy Comptroller Staci Schneider seconded, and the motion was unanimously approved.*
