CASS COUNTY COMMISSIONERS July 6, 2021

The Cass County Commissioners met at 1:00 p.m. in the Commissioners Hearing Room. Present for the meeting were Ryan Browning, Mike Stajduhar, Ruth Baker, Attorney Jeff Stanton, and First Deputy Auditor Michelle Crain.

Ryan Browning opened the meeting with the Pledge of Allegiance.

MINUTES – Ruth Baker made a motion to approve the meeting minutes as presented, Mike Stajduhar seconded. The motion carried unanimously.

CLAIMS & PAYROLL- Ruth Baker made a motion to approve the claims and payroll as presented, Mike Stajduhar seconded. The motion carried unanimously.

HIGHWAY DEPARTMENT – Jeff Smith appeared before the Commissioners with the monthly report for June. Crews finished 3.1 miles of paving and 1.3 miles of chip seal work. Two new drivers are currently in the pre-hire process.

Jeff reported INDOT project updates; US 35 at CR 500 S was closed for the week of June 21st, paving is underway on US 35 between Anoka and Galveston, Third Street Bridge work to Biddle's Island scheduled to be completed by the end of July, bridge painting on US 24/35 over the Wabash River is near completion, and land restrictions are in place for a culvert rehab on SR 18 west of Young America.

Surplus auction held on June 19th netted \$7,102, bulk of the bidding was one dump truck. Jeff thanked the city of Logansport and Rogers Auction service for allowing county to participate again this year.

HEALTH DEPARTMENT – Serenity Alter was unavailable to attend, the following report for the month of June was received and reviewed by Commissioners.

The Health Department held 8 routine immunization clinics. During this report period 101 patients were seen and 279 vaccines given.

Vital Records department received \$2,460 in document fees. The department printed 140 birth certificates, 122 certified death certificates, and 3 paternity affidavits. No request for genealogy searches were received.

Mike Collins completed 65 restaurant inspections; 2 pre-operational, 3 follow-ups, and issued 23 food permits. One environmental follow-up, three lead follow up inspections, and two pool inspections were completed. Dan Musselman completed 10 environmental calls, 6 soil reports, 3 residential inspection, 19 residential searches, and 7 OSS permits.

COVID testing and vaccinations continue to be offered and HIV/HEP testing will be offered in the near future. Cass County remains in code Blue pandemic rating with the number of positive COVID cases decreasing.

PARK DEPARTMENT — Dana Hildebrand presented the monthly report for June. Dana reported estimated revenue \$115,126 was received for the month. Crews prepared the park for the upcoming Fourth of July celebration.

Fund raiser event held for the Blue Iron Motorcycle Club of Monticello, Indiana raised \$600 for those in need. Members of the club include active and retired Police Officers. Entertainment was provided by "Southern Rock Authority Band".
