## Old Business:

Director Fort presented the board with the information on image trend and how the free version is not able to communicate with the Zoll monitors that have been purchased. We would have to purchase the version at a cost of 33,333.00 initial and then an annual payment of 29,327.00. Director Fort recommended to the board that we use ESO with the CAD for our reporting software instead of the image trend version. ESO cost is 18,023 initial purchase with a one time fee of 4,520.00 and then an annual fee of 13,503. He also explained that there may be another option that our guest could explain on the ESO platform.

**Board Attorney** 

Director Fort then introduced the representatives from Med Bill. Med bill had 3 representatives present for the meeting and each spoke on their role in the agency and provided details on what they could provide. Med Bill is a billing agency located in Indiana and currently provides services to over 55 providers in the state of Indiana. Representatives understand that we our under a time crunch and said they could probably have us active in around 30 days this does depend on Medicaid. They assured us that if we are operating and still not active with the billing agency that they can hold all claims for a period of time and then run them once we are online. Med Bill also offers integration with ESO and provided us with a cost of 6.2% of total collections they would waive the 1500.00 set up fee and would lower the .70% compliance package to .25%.

A motion was made by Ed Schroder and second by Dave Morris to proceed ahead with MED Bill continent on the written documentation on the fees discussed. The motion passed 5-0.

Director Fort then spoke on the graphics for the ambulances he is still waiting to hear back from Sutton's and we will discuss at December meeting.
