ORDINANCE 21-03 AN ORDINANCE OF THE CASS COUNTY COMMISSIONERS AMENDING CHAPTER 71, SCHEDULE II, SECTION(S) A OF THE CASS COUNTY CODE

WHEREAS, the Cass County Commissioners believe it is a necessity to temporarily place a limit on thru traveling commercial truck traffic on certain county roads in Tipton Township in order to protect the general traveling public.

WHEREAS, pursuant to further continuing investigation, the Cass County Commissioners have decided that traffic control devices need to be placed on such roadway during the upcoming U.S. 35 construction project between County Road 600 East and County Road 500 South;

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED AS FOLLOWS:

Section I. Chapter 71, Schedule II, Section A of the Cass County Code is hereby amended to add the following regulatory signage:

A. "NO THRU TRUCKS"

All thru commercial trucks are prohibited from using the following roads:

CR 600E FROM US 35 to CR 500S CR 500S FROM CR 600E TO US 35

<u>Section II.</u> Truck Traffic is defined in Chapter 71, Schedule II, Section B of the Cass County Code as the following: "semitrailer"; Every vehicle with or without motive power other than a pull trailer designed for carrying persons or property and for being drawn by a motor vehicle and so constructed that some part of its weight and that of its load rests upon or is carried by another vehicle. "truck tractor"; Every motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to carry a load other than a part of the weight of the vehicle and load so drawn. Furthermore, "Thru" trucks is defined as any truck not having an origin or destination on said section of roadway.

<u>Section III.</u> All prior ordinances, or parts hereof, inconsistent with any provision of this Ordinance are hereby suspended until the end of the US 35 detour during June and July of 2021, at which time this temporary ordinance shall no longer be in effect and all prior ordinances resume.

Section IV.
