

2022 SALARIES – Increase current base salary from \$24,000 to \$26,000, current employees below the \$26,000 base shall increase to \$26,200 and for salary positions hired before January 15, 2022. Increase starting hourly wage from \$9.00 to \$10.00 and increase maximum hourly wage of \$13.50 to \$15.00 at the department head's discretion.

Full-time positions shall receive 5% increase on base salary wages, not to include stipend amounts, excluding departments with specific increases and positions increased to the new base salary of \$26,200.

Payroll for Elected Officials and Full Time salary positions will be divided into 26 equal pays.
