## CASS COUNTY COMMISSIONERS ORDINANCE NO. 2021- 10

## AN ORDINANCE OF THE CASS COUNTY COMMISSIONERS AUTHORIZING FEES FOR EMERGENCY SERVICES PURSUANT TO INDIANA CODE

WHEREAS, Cass County (the "County") has previously passed Ordinance 2021-07 which establishes a County Emergency Medical Ambulance Service and the appointment of a Board to administer those emergency services; and

WHEREAS, Cass County desires to charge a reasonable fee for such Emergency Medical Ambulance Services; and

WHEREAS, I.C.§ 16-31-5-1(5) authorizes Cass County to establish reasonable fees for such Emergency Medical Ambulance Services.

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED AS FOLLOWS:

The Board of Commissioners of Cass County Indiana hereby authorizes the following fees for certain Emergency Services:

(A) Beginning December 13, 2021, the County shall charge as follows:

- (B) In addition to the above, a separate mileage charge of Seventeen Dollars and Sixty-Four Cents (\$17.634) per loaded mile shall be charged for the service provided by the County. These fees include the cost of supplies or medications used or furnished on behalf of the patient.
- (C) There shall be a 40% discount given to any patient who is self pay and receives no benefit from Medicaid, Medicare or private insurance companies.
- (D) In addition to the above charges, an additional charge of One Hundred Twenty-Five Dollars (\$125.00) shall be charged for such services being rendered to any person who is not a resident of the County or of a contractual township.
- (E) For any for-profit unit requesting Intercept Advanced Life Support Services, the charge shall be Fifty Dollars (\$50.00) per man hour, which charge shall be paid no later than thirty (30) days after the issuance of an invoice and any remaining unpaid balance thereafter shall accrue interest at the rate of 1% per month until paid in full.
- (F) If treatment is refused and transport is obtained by Emergency Medical Services crews, Cass County Emergency Medical Services will not charge for said call, unless medication is administered. If medication is administered, Cass County Emergency Medical Services will charge the patient the amount of One Hundred Dollars (\$100.00) per medication administration, with the exception of Naloxone.

(G) These rates may be increased from time to time without amendment of this section so as to adjust as the allowances set by Medicare increase.

This ordinance is hereby passed and adopted at a regular meeting of the County Commissioners of Cass County, Indiana, the 6<sup>th</sup> day of December, 2021.
