ORDINANCE OF THE BOARD OF COMMISSIONERS OF CASS COUNTY, INDIANA ESTABLISHING COUNTY COMMISSIONER AND COUNTY COUNCIL DISTRICTS FOR CASS COUNTY, INDIANA

(Amending Cass County Code of Ordinance § 31.04931.24, Ordinance No)
WHEREAS, The Board of Commissioners of Cass County, Indiana are required to establish County Commissioner Districts in 2021 pursuant to I.C. § 36-2-2-4; and
WHEREAS, The Board of Commissioners of Cass County, Indiana are required to establish County Council Districts in 2021 pursuant to I.C. § 36-2-3-4; and
WHEREAS, the purpose of this ordinance is to establish County Commissioner and County Council election districts in Cass County, Indiana.
NOW THEREFORE BE IT RESOLVED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF CASS COUNTY, INDIANA THAT CASS COUNTY CODE OF ORDINANCES § 31.24, ORDINANCE NO IS AMENDED IN FULL AND REPLACED AS FOLLOWS:
Section 1: Cass County is divided into three (3) County Board of Commissioner election districts, designated numerically as follows:
(a) <u>District One</u> . This District shall consist of all of <u>Adams, Bethlehem, Boone Clay, Harrison, Jefferson and Noble</u> Townships;
(b) <u>District Two</u> . This District shall consist of all of <u>Eel</u> Township; and
(c) <u>District Three</u> . This District shall consist of all of <u>Clinton, Deer Creek, Jackson, Miami, Tipton and Washington</u> Townships.
Section 2: County Council. Cass County is divided into four (4) County Council election districts, designated numerically as follows:
(a) <u>District One</u> . This District shall consist of all of <u>Adams, Bethlehem, Boon, Clay, Harrison, Jefferson and Noble Townships,</u>

(b) <u>District Two</u>. This District shall consist of <u>Eel Township Precincts Logansport</u>

1, Logansport 2, Logansport 3, and Eel West; and

- (c) <u>District Three</u>. This District shall consist of <u>Eel Township Precincts Logansport</u> 4, <u>Logansport 5</u>, <u>Logansport 6</u>, <u>Logansport 7</u>, <u>Eel East, Eel East Nonvoting</u>, <u>and Eel North</u>; and
- (d) <u>District Four</u>. This District shall consist of all of <u>Clinton</u>, <u>Deer Creek</u>, <u>Jackson</u>, <u>Miami</u>, <u>Tipton and Washington</u> Townships,

Section 3: All ordinances (including Cass County Code of Ordinance § 31.04 \(\frac{2}{31.04}\), Ordinance No) and/or parts of ordinances in conflict herewith, are
hereby repealed.
Section 4: If any section, subsection, sentence, clause, phrase or portion of this Ordinance shall for any reason be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereunder.
Section 5: This Ordinance shall be in full force and effect from and after its passage by the Board of Commissioners of Cass County, and completion of any other legal requirements, all in a manner provided by law.
