

ORDINANCE 2022- 17

AN ORDINANCE OF THE CASS COUNTY COMMISSIONERS, LOGANSPORT,  
VACATING A CERTAIN STREET IN THE COUNTY OF CASS

WHEREAS, on proper petition after public notice and hearing as provided by law, the Cass County Commissioners, Logansport, Indiana have heard evidence and testimony recommending that a certain street be vacated and abandoned, such street being fully described in the attached Exhibit; and

WHEREAS, the Cass County Commissioners, Logansport, Indiana have solicited input or accepted a waiver from adjoining landowners that might be affected by the vacation of said street, and the vacation of said street will have no adverse effect to them; and

WHEREAS, it is the desire of the Cass County Commissioners, Logansport, Indiana to vacate the above-described street in its entirety, and

NOW THEREFORE, BE IT ORDAINED by the Cass County Commissioners, Logansport, Indiana


SECTION 1. That the new legal description of the street as vacated should be described as part of the adjoining landowners, Kimberley L. Miller and John Glen Hines.

SECTION 2. That the vacation of said street will not hinder the growth or development of the neighborhood in which it is located; will not make access to lands to any person by means of public way difficult or inconvenient; will not hinder the public's access to any church, school, or any public building or place; or hinder the public way, and is not for public benefit or use.


SECTION 3. That this ordinance shall be in effect after its passage by the Cass County Commissioners, Logansport, Indiana.

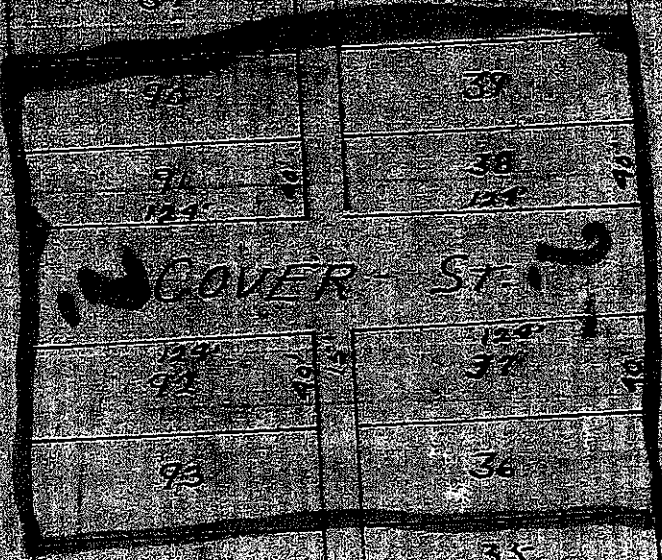
