

CASS COUNTY COUNCIL ORDINANCE NO. 2024-03

ORDINANCE CREATING AN EMERGENCY MEDICAL SERVICE  
NON-REVERTING FUND  
FOR AMBULANCE AND MEDICAL TRANSPORTATION SERVICES

WHEREAS, on October 4, 2021, the Cass County Commissioners established a County Emergency Medical Ambulance Service by Ordinance 21-07; and

WHEREAS, on January 16, 2024, the Cass County Commissioners approved the Agreement for Ambulance and Medical Transportation Services between Cass County Emergency Medical Services and Logansport Memorial Hospital; and

WHEREAS, the Cass County Council desires that the revenue and reimbursements generated from the Agreement for Ambulance and Medical Transportation Services with Logansport Memorial Hospital be deposited into a non-reverting fund (EMS Transportation Service Non-Reverting Fund 4545) which, in addition to any other money provided by the County Council, will be utilized to pay salaries of county emergency medical service employees providing services to Logansport Memorial Hospital pursuant to the Agreement for Ambulance and Medical Transportation Services.

NOW, THEREFORE, BE IT RESOLVED BY THE CASS COUNTY COUNCIL AS FOLLOWS:

1. This Ordinance creates an EMS Transportation Service Non-Reverting Fund 4545 for revenue and reimbursements received for services provided by the Cass County Emergency Medical Services to Logansport Memorial Hospital under the Agreement For Ambulance and Medical Transportation Services.

2. The money in EMS Transportation Service Non-Reverting Fund 4545 shall remain in said fund until expended and shall not revert to the general fund at the end of the county's fiscal year.

3. The monies in EMS Transportation Service Non-Reverting Fund 4545 shall be utilized to pay all expenses incurred by Cass County Emergency Services related to services provided to Logansport Memorial Hospital pursuant to the Agreement for Ambulance and Medical Transportation Services, including but not limited to salaries and benefits of employees.

4. The initial “startup” expenses incurred by Cass County Emergency Medical Services to provide service to Logansport Memorial Hospital pursuant to the Agreement shall initially be paid from EMS Ambulance Non-Reverting Fund 4949. EMS Transportation Service Non-Reverting Fund 4545 will then reimburse to EMS Ambulance Non-Reverting Fund 4949 the “startup” expenses at the end of the calendar year, unless approved otherwise by the County Council.


5. The revenue received for EMS Transportation Service shall be deposited into county operating account.






