Claims: Ryan asked Christy to go through the April claims. Christy presented the following claims:

HWC for \$26,615.22 for professional fees for the fire protection project, Patriot Engineering and Environmental, Inc. for 4,000 for Geotechnical Investigation for Site Certification, Baker Tilly Municipal Advisors, LLC for \$2,975.75 for professional services, Terzo & Bologna for \$9,450 for land appraisals, Advisio for \$7500 for land appraisals.

From the Redevelopment District Bonds of 2021: Division A – Water Mains to HRP Construction for \$319,922.99 for water mains for the fire protection system. From the Maintenance Fund: LMU for \$444.01 and \$401.01 for electric service to the well field and \$311.58 and \$145.40 to the elevated tank, and \$42 and 42.60 for the Cass Co Agribusiness Park Sign, NIPSCO for \$60.79 for gas service to the well field. Dave made a motion to approve the claims as presented, seconded by Bruce; Motion carried.

Bruce made a motion to approve the Patriot Engineering & Environmental, Inc. ICP Closure Change Order Proposal for 4 additional quarters of testing, seconded by Ruth; Motion carried.

Ruth made a motion to approve the proposal from Clifford Signs for \$8,186.00 for the Cass Co Agribusiness Park Directional Sign, seconded by Bruce. Motion carried.

Bruce made a motion to extend the request for additional time from HRP Construction to final competition to 8/1/22, if HRP Construction will reimburse the RDC for engineering expenses incurred by the time extension and to table Division A – Change order #3 to install a water flushing station for \$24,655 for additional information, seconded by Dave. Motion carried.
