**BE IT FURTHER RESOLVED** that this Board will adhere to the provisions of Indiana Code 36-9-14.5-1 The proposed fund will not exceed \$.04 on each \$100 of assessed valuation. Said tax rate will be levied beginning with taxes for 2020 payable 20201

**BE IT FURTHER RESOLVED** that proofs of publication of the public hearing held on the 16<sup>th</sup> day of March, 2020, and a certified copy of this resolution shall be submitted to the Department of Local Government Finance of the State of Indiana as provided by law. This Cumulative Fund is subject to the approval of the Department of Local Government Finance.
