## RESOLUTION NO. 2021-04

## A RESOLUTION OF THE CASS COUNTY COUNCIL APPROVING BANK LOANS TO FINANCE RECONSTRUCTION OF A REGULATED DRAIN "THE GARY MILLER OPEN & TILE"

WHEREAS, IC 36-9-27-97.5(a) provides:

- (a) Whenever a Drainage Board determines by resolution spread upon its minutes that the cost of constructing or reconstructing a particular drain is an amount that the owners of land to be assessed may conveniently pay in installments over a five (5) year period, it may ask the county fiscal body to;
- (1) obtain a loan from a bank, trust company, savings association, or savings bank authorized to engage in business in this county;
- (2) to finance that construction or reconstruction

WHEREAS, on May 14, 2021, the Joint Drainage Board of Cass, Miami and Fulton Counties (the "Joint Board") adopted Resolution 2021-01 determining that the cost of reconstructing the Gary Miller Open & Tile listed on Exhibit A would be in an amount that the Owners may conveniently pay in installments over five (5) years; and

WHEREAS, the Joint Board also determined that the Response to the Joint Board's Request for Quotes submitted by First Farmers Bank & Trust dated June 1, 2021, meets the requirements of I.C. 36-9-27-97.5 ("Response"); and

WHEREAS, Joint Drainage Board Resolution No. 2021-02 requests this Council to approve First Farmers Bank & Trust's Response and authorize the Board to proceed with bank financing.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL THAT:

- 1. First Farmers Bank & Trust's Response as a means to finance the reconstruction of the Gary Miller Open & Tile listed on Exhibit A, or so many of them as the Joint Board shall order reconstructed, is hereby approved.
- 2. The Joint Board is hereby authorized to accept and execute the Response and to take such further action as is necessary to borrow funds from First Farmers Bank & Trust.
- 3. This Resolution shall be effective immediately upon adoption by the Council.
- 4. That the Cass County Council grants authority to Ryan Browning, Chairman of the Gary Miller Open & Tile Joint Drainage Board, to sign on behalf of Cass County Council and financial documentation necessary for the loan documents for the Gary Miller Open & Tile Joint Drainage Board Project.
