CASS COUNTY COUNCIL RESOLUTION NO. 2024-08

JOINT RESOLUTION OF THE CASS COUNTY COMMISSIONERS  
AND CASS COUNTY COUNCIL APPROPRIATING \$3,000,000.00  
FROM LIT COUNTY ECONOMIC DEVELOPMENT FUNDS TO  
LOGANSFORT MEMORIAL HOSPITAL

WHEREAS, the Cass County Council serves as the fiduciary body of Cass County, Indiana; and

WHEREAS, Logansport Memorial Hospital is established as a County Hospital pursuant to Indiana Code, serving the medical needs of the citizens of Cass County and surrounding area; and

WHEREAS, Logansport Memorial Hospital employs approximately 700 full time employees and provides a significant economic benefit to the community; and

WHEREAS, the Cass County Council believes that it is in the best interest of Cass County to financially support and maintain Logansport Memorial Hospital as a viable asset to the community; and

WHEREAS, the Cass County Council believes that it is in the best interest of the County to support the hospital financially with the appropriation of funds to secure its economic and financial viability and stability in the coming years; and

WHEREAS, the Cass County Council believes that it is in best interest of the community to maintain and support a hospital with as many medical services as possible, so that the County's medical needs can be addressed locally rather than requiring its citizens to travel great distance for medical treatment; and

WHEREAS, subject to the Cass County Commissioners and Logansport Memorial Hospital negotiating the terms of and executing an Economic Development Agreement and so long as such Agreement is consistent with Indiana law, the Cass County Council hereby agrees to support the hospital with an appropriation/contribution from the County of Three Million Dollars (\$3,000,000.00); and

WHEREAS, by executing this Joint Resolution the Cass County Commissioners hereby make a positive recommendation to support such an

appropriation to Logansport Memorial Hospital; and


WHEREAS, Cass County agrees to appropriate Three Million Dollars (\$3,000,000.00) to Logansport Memorial Hospital in year 2024 from LIT County Economic Development funds.


