






**CLARK COUNTY ELECTION BOARD
MINUTES OF MEETING
OCTOBER 30, 2023**

A meeting of the Clark County Election Board was held at the Clark County Courthouse, Voter Registration Office, 501 East Court Avenue, Jeffersonville, Indiana, on October 30, 2023.

The following Board Members were present: Democrat Chairman, Andrew Steele, Republican Representative, Tony Singleton, and Clark County Clerk, Ryan Lynch. Andrew Steele called the meeting to order at 4:51 p.m. Also present was Angela Cornett, Voter Registration employee, Gavan Hebner and William Bower of the Clark County Emergency Agency. Notice of the meeting was published.

The first matter before the Board is Old Business. Gavan Hebner presents the County Election and Polling Place Security Plan for Clark County, Indiana and the Incident Action Plan for the Clark County 2023 General Election. This plan will be incorporated into the record. The Clerk will need to have a line of succession in case the elected Clerk is incapacitated. The line of succession will be 1st Deputy Clerk, Pamela Vonsenden, and then Angela Cornett, Voter Registration employee. According to the Plan the Board members will need to have proxies for Election Day. Andrew Steele makes a motion to adopt the Plan. Seconded by Ryan Lynch. Carried 3-0. The Plan will be forwarded to the Commissioners.

The next matter before the Board is challenged signatures. members are to review the plan and will discuss it at the next meeting. Once the plan and has been reviewed and approved, it will be submitted to the Commissioners for their approval. Kelly Khuri requests that a copy of the plan be mailed to her. Early voting has begun and is running smoothly. Approximately 100 voters have voted already.

The next matter before the Boards is the CFA 4 forms. These forms will need to be filed by the candidates on or before October 20, 2023 at 12:00 p.m. The Board also advises that the Public Test was ran last week and went very well. The test has already been certified to the State. William Vissing and Nicholas Mobley will be testing all machines before the upcoming election. The poll workers will be asked to check the zero tapes and bins before Election Day. Training will start next week at the Ken Ellis Center from 6:00 p.m. to 8:00 p.m. Training for Clerks will be October 24 and November 1, 2023. Training for Judges will be October 25 and November 2, 2023. Training for Inspectors will be held on October 26 and October 30, 2023.

Kaitlen Blessitt addresses the Board regarding emails on KnowInk and other issues, including reports submitted. The Board will be the first recourse regarding these issues.
