A. Standard Operating Procedures (SOPs) - Campaign Finance

Clerk Ryan Lynch developed SOPs for processing campaign finance filings.

IED Feedback: The Indiana Election Division attorneys and campaign finance enforcement staff reviewed the SOPs and were pleased and gave a couple revisions to add.

Revisions Made:

- Added checklist for Schedule D (debts owed by a committee) and Schedule E (debts owed to a committee), to be attached when such schedules are filed.
- Added requirement that the board notify committees within 30 days of a missed filing deadline.

Process Overview:

- Staff will complete the checklist when reports are submitted.
- If no issues: filing signed off and archived.
- If issues: committee notified, matter brought before the Election Board at its next meeting for determination.

Action: Motion by Steele to adopt the SOPs as official procedure.

Second: Singleton

Vote: Unanimous approval.

B. Campaign Finance Complaint Update

Clerk Lynch reported the matter is still in progress.

The Election Board had previously drafted and submitted a letter.

Concern was raised before by the receiving party regarding confidential information.
