JRAC Business

- I. Welcome: Leah Pezzarossi, Exec Director of Youth Shelter to serve on JRAC Board and appointed to our JRAC Subcommittee on Mental Health and Addiction.
- II. Spotlight on our local organization work: CASA presentation
 - a. CASA of Floyd County empowers community members to advocate for abused and neglected children, aiming for a safe and positive future through competent volunteer advocacy. CASA volunteers focus on intensive, one-on-one advocacy, building relationships with the child and those involved in their case. Volunteers sworn in as officers of the court could be the only consistent adults in the child's life. They are trained before being assigned a case and receive ongoing support, focusing on safety, permanency, and building resilience. The children in the CASA program have been through trauma and have a high amount of adverse childhood experiences. The average ACE score of a child in the program is 6.75, with 60% of the children having or having had an incarcerated caregiver, and 70% having a caregiver that misuses drugs or alcohol. Mitigating trauma is a vital part of CASA's vision for a brighter future for the children in Floyd County.
