- III. NEW BUSINESS/Updates
 - A. Opioid Settlement Fund Work Group updates Connie Moon MH and Addiction Resource Support Work Group Review recommendations of work group for distribution of opioid funding. Moon, Randelia, and Bass from the work group in attendance and explained process. They focused their scoring on achieving the JRAC Mission and community collaboration. All 5 members scored all the applications and then scores were averaged. Discussion regarding utilizing the scoring of the application to determine the approved candidates for the opioid funding, the top six applications total cost would be \$284,090. Motion to present this plan to the full board Oct 21 meeting by Elliott. Motion was presented blindly in that Moon was the only person who had knowledge of the averaged rubric scoring and who the top candidates would be. Motion was seconded by Pezzarossi. Unanimous approval with 2 judges, 3 work group members, and 2 present who participated in application for grant funding abstaining from the vote. Unanimous approval (15 of 24 in attendance, 7 abstaining). Moon work group will present at 10/21 meeting.
 - B. Update from Judge Stiller CEPP present for site visit and interviews of statutory stakeholders. They are assisting our group in setting goals for JRAC. Goals will continue to be discussed in future meetings.
 - C. Justice Counts Introduction and presentation offering BJA funded organization who provides data collection services.
 - D. Resource Guide update: SOC and FCHD partnership to prepare Resource Guide (HELP IS HERE) Charlotte reports that they have completed and will provide for us to review as a group. SOC will send the New Hope Resource guide for our review as well.
 - E. CLARK/FLOYD SYSTEM OF CARE Request for renewed funding support from opioid funds for their fiscal year Oct 2024 to Oct 2025. (Last year we approved for one year but to be revisited this year for the second year of funding.) They will be added to 10/21 agenda for presentation and vote.
 - F. Health Dept report Floyd County suicide rate is higher than state average. Health Dept will be working on initiatives to combat this issue.
