

**FLOYD COUNTY BOARD OF COMMISSIONERS PLAN REGARDING THE  
PROPOSED DISSOLUTION OF THE FLOYD COUNTY SOLID WASTE  
MANAGEMENT DISTRICT**

1. The Floyd County Commissioners hereby establish a Plan for the proposed Dissolution of the Floyd County Solid Waste Management District.
2. Effective Date: The Floyd County Solid Waste Management District shall cease to operate as of February 27, 2026 at 11:59 p.m. All rights, duties, and authority of the Floyd County Solid Waste Management District shall be transferred to the Floyd County Commissioners, under the department known as Floyd County Solid Waste.
3. Assets/Obligations: All assets and obligations of the Floyd County Solid Waste Management District shall be transferred to the Floyd County Commissioners and shall be held and titled in the name of Floyd County, Indiana. The assets shall be used to provide ongoing services under the Floyd County Commissioners. A list of all vehicles, equipment, and personal property of the Floyd County Solid Waste Management District is hereby attached and labeled Floyd County Solid Waste Management District Equipment Inventory/Capital Assets.
4. Employees: All employees of the Floyd County Solid Waste Management District shall continue to be employed but shall be employees of the County and shall be under the supervision of the Floyd County Commissioners, under the department known as Floyd County Solid Waste. All such employees shall be at-will employees and shall report to the Floyd County Commissioners. In addition, all employees shall follow and be employed pursuant to all normal county procedures and the Floyd County employee handbook.
5. Services:
  - a. Current services:
    - i. 2 recycling drop off centers
      1. One is located in Galena and accepts paper, cardboard, plastics, metal, glass, scrap metal, and aluminum cans.
      2. The other is located in New Albany (The Annex) and accepts paper, cardboard, plastics, metal, glass, scrap metal, and aluminum cans. E-waste and Household Hazard Waste at certain times of the year (currently April-October one time per month)
    - ii. Cardboard pick up service for 36 local businesses, schools, government centers and charities.
  - b. Proposed services: The Floyd County Commissioners will assume responsibility for providing ongoing services after the effective date of the dissolution and may amend the services that are proposed to be provided. The Floyd County Commissioners intend to continue to have a recycling drop off center, at the New

Albany (The Annex), to accept paper, cardboard, plastics, metal, glass, scrap metal, and aluminum cans. The Floyd County Commissioners also intend to continue to offer the recycling drop off center at the Galena location until such time that the term of the use of that property expires (currently set to be July 1, 2026). The Commissioners are evaluating bids on collection and disposal of Household Hazard Waste and plan to continue offering a service for this. The Commissioners intend to create a non- reverting fund for the Solid Waste department.

6. Education: The Floyd County Commissioners will strive to continue to educate the public as to the services offered.
