FCCC (Part F, #1, 2)	Funding for one full-time personnel to perform biopsychosocial assessments for affected criminal justice involved individuals referred by the criminal courts using evidence based methods and connecting those individuals to treatment and recovery support services. This allows for warm hand-off of services to transition to recovery services. This position would require at minimum a Bachelor's degree and appropriate experience. The amount includes salary and benefits. This is another key part of our CARES program. *The term would be for two years beginning at point of hiring.	Year 1	Year 2
