David Hall, NAFC Animal Shelter Director, asked if this amount includes the \$4,750.00 for Georgetown. Brad Striegel stated he wasn't sure. Susan Rosenbarger, NAFC Animal Shelter Board member, stated that they were unaware that this was the amount the County was going to pay. The agreement states that the County is to pay 51% of their budget. Ms. Rosenbarger stated that their budget was tabled last year and nothing was ever addressed. Denise Konkle stated that based on the Animal Shelter Budget the County still owes another \$86,000.00. Leslie Knable stated that she is willing to be the liaison between the Animal Shelter, New Albany City and the County.

The agreement states that the County pay 51% and the City pay 49% of the Animal Shelter budget based on population. The County would like to speak with the City Council to discuss the breakdown and have transparency on how this breakdown was determined and if it is fair. Danny Short, Adam Roberts and Dale Bagshaw met with members of the New Albany City Council. Danny Short stated that the City County told them it was an executive decision and the County needs to pay the bill. He stated that meeting turned abrasive in less than 5 minutes. Motion to approve. Moved by Danny Short. Seconded by Dale Bagshaw. Motion passed unanimously.
