2. <u>DISCUSSION OF THE ARP FUNDS/LIST OF PROJECTS/FRAMEWORK.</u>

Don Lopp stated that they are waiting on more information on the guidelines of the American Rescue Plan. An ordinance and fund have been established. The first installment will be 50%. The most important aspect is to get the processes and procedures down.

3. <u>NEW ALBANY – FLOYD COUNTY ANIMAL SHELTER</u> <u>AGREEMENT DISCUSSION.</u>

Connie Moon stated she feels the Animal Shelter's Budget should be the total disbursements minus the estimated revenue. According to her figures from the information she got from the Auditor's office that the County has overpaid over \$96,000.00 over the last 10 years.

Attorney Rick Fox stated that according to the Inter-Local Agreement between the City of New Albany and the County the two bodies are to agree on a budget and the County is to pay 51% of the agreed upon budget. If no budget is agreed upon then there isn't a budget. So far the City has not sat down with the County to discuss.

Danny Short stated that the Commissioners and the Mayor need to rewrite the Inter-Local Agreement. He stated the budget that was presented to the Council was for \$600,000.00 but their expenditures only equaled \$500,000.00 not including revenue. The County is expected to pay 51% of the \$600,000.00.

Denise Konkle stated that she feels they have 2 options. They cannot pay the Animal Shelter and take the risk of breaking up the Animal Shelter and spending tax payer money on litigations or pay what the County feels is their portion based on last year's expenditures. She would like to pay what she believes is the fair amount and wait for the next Mayor to be in office in hopes that they will be willing to sit down with the County and discuss.
