

**JOINT RESOLUTION  
BY AND BETWEEN THE TOWN OF GEORGETOWN, INDIANA  
AND FLOYD COUNTY, INDIANA**

WHEREAS, Floyd County, Indiana (hereinafter referred to as "Floyd County") owns real property, located off Georgetown Lanesville Rd, Georgetown IN 47122. Said property has a parcel number, number 22-02-03-200-397.000-003; and

WHEREAS, Floyd County no longer needs said real property and hereby designates it as surplus property; and

WHEREAS, the Town of Georgetown, Indiana (hereinafter referred to as "Georgetown") is in need the property as part of its Park Project (a renovation of a Park for the benefit and use of citizens in Georgetown and surrounding jurisdictions); and

WHEREAS, Floyd County wishes to dispose of said property and Georgetown desires to have said property; and

WHEREAS, Floyd County and Georgetown find, pursuant to Indiana Code 36-1-11-8, that the transfer of said property to Georgetown is appropriate;


WHEREAS, Floyd County and Georgetown find the real property being marked as surplus with nominal or no value is fair and that a determination of fair market value is not required pursuant to Indiana Code 36-1-11-8;


