**JOINT RESOLUTION OF THE
FLOYD COUNTY, INDIANA COMMISSIONERS
AND FLOYD COUNTY, INDIANA COUNCIL**

WHEREAS, the Board of Commissioners for Floyd County, Indiana (hereinafter referred to as "Commissioners") is the executive and legislative bodies of Floyd County, Indiana;

WHEREAS, the County Council for Floyd County, Indiana (hereinafter referred to as "Council") is the fiscal body of Floyd County, Indiana;

WHEREAS, Floyd County, Indiana has discovered some historical adjustments that need to be made to the Floyd County, Indiana records and accounts of the County;

WHEREAS, the Commissioners and Council have been provided with details of the historical adjustments requested from the County Auditor and County Treasurer; and

WHEREAS, the Commissioners and Council desire to make necessary adjustments to the Cashbooks and Funds of the County to ensure accuracy in the County cashbook and funds.

**NOW, THEREFORE, BE IT RESOLVED BY FLOYD COUNTY,
INDIANA BY AND THROUGH THE COMMISSIONERS AND COUNCIL:**

1. The Floyd County Commissioners and Floyd County Council desire to make necessary historical adjustments to the County Cashbooks and Funds to ensure accuracy.
2. That the Auditor and Treasurer have consistently shown the same difference and outage as unchanging for the prior six (6) months to help verify accuracy of the numbers.
3. That the following amounts shall be corrected in the County Cashbook, totaling - \$305,884.33:
 - a. -\$323,722.29 from bank #003
 - b. +\$16,635.82 to bank #002
 - c. -\$72.59 from bank #008
 - d. +\$1,274.73 to bank #009
4. That the County Funds shall be adjusted in the amount of -\$470,679.22 to bring them into balance with the Cashbook.
5. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.
6. Any resolution or parts of resolutions in conflict with this Resolution shall be deemed null and void, and are repealed.

7. This Resolution shall be in full force and effect from the date of passage and forever after its passage and execution.

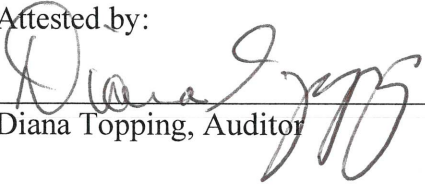
