7. HR Director-Arnie Schnobrich

a. Humana Contract

Mr. Schnobrich stated that the County's claims surpassed the premiums paid this year. The employees will have 2 plans to choose from in 2020. A High Deductible plan will be introduced as well as the original plan. The High Deductible plan will have a \$0.00 premium for Employee only with up to \$750.00 put in an account to offset the high deductible. Participating in Go365 will reduce the rates. Employees have 5 full months to reach the Silver level. Failure to reach the Silver level by June 1 will result in higher premiums. The Vision Plan stayed the same and Dental went up slightly.

Motion to approve the Health Insurance Contract. Moved by John Schellenberger; seconded by Shawn Carruthers. Motion passed unanimously.

Motion that any additional forms that need to be signed can be signed outside of the meeting. Moved by John Schellenberger; seconded by Shawn Carruthers. Motion passed unanimously.

Mr. Schnobrich added open enrollment will begin November 12, 2019. Individuals will have the ability to enroll online through a portal. Provisions will be made to individuals that do not have internet access.
