- 2. Invest approximately 14.7 million in to the Legacy Silo.
- 3. The Commissioner will get the spend rate of 5% with a 3-year average.
- 4. The Council will get the Community Foundation Spend rate.
- 5. The term will be 10 years.
- 6. The remaining approximately 2 million will be split between the Council and Commissioners.
