e. Paint Truck Purchase Order

The purchase order is for a used paint truck. The truck is a 1998 model with 112,000 miles for \$65,000.00. Mr. Lopp received quotes on outsourcing the striping of roads. Mac Construction quoted \$60,000.00 for the section of roads that they have paved. Libs Paving quoted \$260,000.00 for the section of roads that they have paved. For comparison, our cost would be \$28,000.00 by striping the same sections of road with our own equipment.

Motion to approve the purchase of the paint truck pending the approval of the transfer of fund by the County Council. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

f. Paving Update

Don Lopp stated the remaining roads that will be paved this year is North Luther, East Luther, Buttontown, Old Vincennes and Kepley. They should be finished by the end of October. By the end of this year over half of the roads in the county will be rated 8 or above.

They have worked with them since the inception of the bond. They are anticipating the bond being 8-9 million dollars. Crowe's charge is \$68,000.00, which will come out of bond proceeds.
