Matt Hall, Executive Vice President of One Southern Indiana gave a review of 2019. The 2019 Projects for Floyd County resulted in 497 new jobs equating to an annual payroll of \$35,105,699.00. Capital investment of those projects equated to over 26 million dollars. Since 2006 One Southern Indiana has announced 176 new projects in Clark and Floyd Counties with 58 were in Floyd County creating almost 3,000 jobs.

Wendy Dant-Chester, President of One Southern Indiana, spoke on Our Southern Indiana Regional Development Authority. She thanked Brad Striegel, County Council, for all his help on forming RDA in 2017. The Region consists of Clark, Floyd, Scott, Washington and Jefferson Counties. They received a grant from Indiana Economic Development Cooperation to update a Regional Economic Development Strategy Plan. The plan can be found on their website www.oursoinrda.org. Governor Eric Holcomb was excited about the plan. She thanked the Commissioners and Council members that were involved.
