He stated the Conservation Concept is nothing but a ruse to promote intense development for the financial advantage of the developers and builders. He feels the entire process, from choosing the committee to the signing of FCO2019-23, was done with as much secrecy as the law will allow. He feels the Conservation Subdivision does not preserve the rural atmosphere of the county. He requested the Commissioners declare a moratorium on Conservation Subdivision and zoning changes while there are none applied for. Mr. Mouser asked the public, by a show of hands, if they agree with him. A few people raised their hands.

Dale Mann, Georgetown, stated that the Commissioners did not show Mr. Mouser the proper respect he deserved when he was speaking. He agrees with Mr. Mouser on Conservation

Subdivision. He was on the Conservation Subdivision committee with former Commissioner, Billy Stewart and tried to persuade members to put off another subdivision but felt no one was listening. The current subdivision on Henriott Road has seven houses on one acre of land.

Shawn Carruthers stated that there will be on Caucus on Thursday, January 23 to vote in a new Commissioner.
